Pursuant to General Circular Nos. 14/2020, 17/2020, 20/2020, 02/2021, 19/2021, 21/2021 and 02/2022 dated April 8, 2020, April 13, 2020, May 5, 2020, January 13, 2021, December 08, 2021, December 14, 2021 and May 05, 2022 the latest being General Circular No.03/2025 dated 22nd September 2025 respectively issued by the Ministry of Corporate Affairs ('MCA') (collectively referred to as 'MCA Circulars') and Circular Nos. The proceedings of the AGM will be deemed to be conducted at the Registered Office of the Company which shall be the deemed Venue of the AGM.
2. **IN TERMS OF THE MCA CIRCULARS AND THE SEBI CIRCULARS, THE REQUIREMENT OF SENDING PROXY FORMS TO HOLDERS OF SECURITIES AS PER PROVISIONS OF SECTION 105 OF THE ACT READ WITH REGULATION 44(4) OF THE LISTING REGULATIONS, HAS BEEN DISPENSED WITH. THEREFORE, THE FACILITY TO APPOINT PROXY BY THE MEMBERS WILL NOT BE AVAILABLE AND CONSEQUENTLY, THE PROXY FORM AND ATTENDANCE SLIP ARE NOT ANNEXED TO THIS NOTICE CONVENING THE 21st AGM OF THE COMPANY (THE "NOTICE").**
3. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and the aforesaid MCA and SEBI Circulars, the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has entered into an agreement with National Securities Depository Limited (NSDL) for facilitating voting through electronic means, as the authorized agency. The facility of casting votes by a member using remote e-voting system as well as venue voting on the date of the AGM will be provided by NSDL.
4. The Board of Directors has appointed Mr. Ajay Kumar Prajapati Prop. M/s APK & Associates, Company Secretaries (ACS No. 49295, CP No. 28412) as the Scrutinizer to scrutinize the voting and remote e-voting process in a fair and transparent manner.
5. In pursuance of Section 113 of the Act and Rules framed thereunder, the corporate members are entitled to appoint authorized representatives for the purpose of voting through remote e-Voting or for the participation and e-Voting during the AGM, through VC or OAVM. Institutional Shareholders (i.e., other than individuals, HUF, NRI etc.) are required to send scanned copy (PDF / JPG Format) of the relevant Board Resolution / Power of Attorney / appropriate Authorization Letter together with attested specimen signature(s) of the duly authorized signatory(ies) who are authorized to vote, to the Company Secretary through e-mail at csakg@akg-global.com with a copy marked to evoting@nsdl.co.in.
6. Since the 21st AGM will be held through VC or OAVM, no Route Map is being provided with the Notice.

7. Members attending the AGM through VC / OAVM shall be counted for the purpose of reckoning the quorum under Section 103 of the Act.
8. For ease of conduct, members who would like to ask questions/express their views on the items of the business to be transacted at the meeting can send in their questions/ comments in advance mentioning their name, demat account number/ folio number, email id, mobile number at csakg@akg-global.com. The same will be replied by the Company suitably. Those Members who have registered themselves as a speaker will only be allowed to express their views/ask questions during the AGM. The Company reserves the right to restrict the number of speakers depending on the availability of time for the AGM.

Members can login and join the AGM 30 minutes prior to the scheduled time to start the AGM and the window for joining shall be kept open till the expiry of 15 minutes after the scheduled time to start the AGM. However, the participation of large members (members holding 2% or more shareholding), promoters, institutional investors, directors, key managerial personnel, the Chairpersons of the Audit Committee, Nomination & Remuneration Committee, Stakeholders Relationship Committee and Auditors can attend the AGM without restriction of first-come-first served basis. Instructions and other information for members for attending the AGM through VC/OAVM are given in this Notice.
10. The Register of Members and share transfer books of the Company will remain closed from Sunday, 20th September, 2026 to Saturday, 26th September, 2026 (both days inclusive), for the purpose of Annual General Meeting.
11. In case of Joint-holders, the Member whose name appears as the first holder in the order of names as per the Register of Members of the Company will be entitled to vote during the AGM.
12. Register of Directors and Key Managerial Personnel and their shareholding maintained under section 170 of the Act, and the Register of Contracts or Arrangements in which the Directors are interested, maintained under the Companies Act, 2013 will be available electronically for inspection by the members upto & including the day of AGM. 13. Statement pursuant to Section 102 of the Act and the rules made thereunder setting out the material facts and the reasons for the proposed resolutions, in respect of the Businesses under Item No. 3, 4, 5, 6 & 7 is annexed hereto. The relevant details of the Directors as mentioned under Item No(s). 3 and 6 above as required by Regulation 36(3) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirement) Regulations, 2015 ("Listing Regulations") and as required under Secretarial Standards – 2 on General Meetings issued by the Institute of Company Secretaries of India, is annexed thereto.
14. The Board of Directors have considered and decided to include the Item No(s). 3 to 7 given above as Special Businesses in the forthcoming AGM, as they are unavoidable in nature.
15. Pursuant to Regulation 40 of the Listing Regulations, the securities of listed companies can be transferred only in the dematerialized mode w.e.f. April 1, 2019, except in case of transmission or transposition of securities. In this regard, SEBI has clarified by a Press Release No. 12/2019 dated March 27, 2019, that the said amendments do not prohibit an investor from holding the shares in physical mode and the investor has the option of holding shares in physical mode even after April 1, 2019. However, any investor who is desirous of transferring shares (which are held in physical mode) after April 1, 2019 can do so only after the shares are dematerialized. SEBI vide its Circular No. SEBI/HO/MIRSD/RTAMB/ CIR/P/2020/166 dated September 7, 2020 has fixed March 31, 2021 as the cut-off date for re-lodgement of transfer deeds. Further, the shares that are re-lodged for transfer (including those requests that are pending with the

Company / RTA) shall henceforth be issued only in demat mode. In exceptional cases, the transfer of physical shares is subject to the procedural formalities as prescribed under SEBI Circular No. SEBI/HO/MIRSD/DOS3/CIR/P/2018/139 dated November 6, 2018.

16. Further during the period under review Mr. Kalapi Vinit Nagada (Acquirer) has made Open Offer to the public shareholders of AKG Exim Limited (Target Company) for acquisition of 82,62,000 fully paid-up shares of face value of Rs.10 each at consideration of Rs.15 each equity share, representing 26% of the voting equity share capital of the company, further it was observed that the public shareholders has accepted the offer for 41,58,862 equity shares representing 13.9% of the issued and paid-up equity share capital of the Company at consideration of Rs.15 each equity shares and same was acquired by Mr. Kalapi Vinit Nagada.

Further the post offer holdings of Mr. Kalapi Vinit Nagada were 1,14,98,062 representing 36.18% of total issue paid up equity share capital of the company.

During the period under review Mrs. Mahima Goel (DIN:02205003) was re-appointed as Managing director for the term of 5 years, further it was observed that Mrs. Mahima Goel was abstained from voting for this item.

During the period under review the remuneration of Mr. Rajeev Goel (Non-Executive Director) was approved by shareholders in the annual general meeting by passing the special resolution, further it was observed that Mr. Rajeev Goel was abstained from voting for this item during the approval and recommendation in the relevant board meeting.

During the period under review Mr. Rao laxman Singh (Independent Director) was re-appointed for another term of 5 years.

During the period under review M/s. Sharma Sharma & Co., Chartered Accountants has been appointed to act as an Internal Auditor of the Company for the financial year 2025-26.

During the period under review the sale agreement has been executed between AKG EXIM LIMITED (the company) and M/s MLH Ventures LLP in respect of Company's property situated at Unit No. 237 and Unit No. 238, 2nd Floor, Tower-B, Spazedge, Sector-47, Sohna Road, Gurugram-122018.

During the period under review, it was observed that the company has changed its registered office within the local limits of the same city/town/village from Unit No. 237, 2nd Floor, Tower-B, Spazedge, Sector-47, Sohna Road, Gurugram-122018, Haryana (sold to MLH Ventures LLP) to Unit No. 231, 2nd Floor, Tower-B, Spazedge, Sector-47, Sohna Road, Gurugram-122018, Haryana.

During the period under review, it was observed that the board of directors has approved the sale/assignment of trademark (HEALTH RICH (LABEL)), owned by the company to M/s MLH Ventures LLP for fixed consideration of Rs.1,00,000.

During the period under review the company has paid all its statutory dues.

During the audit it was observed that few minutes of board meeting were recorded beyond the period of 30 days in the minute book, as for the same the management has commented below:

The Management acknowledges that there were certain instances where the proceedings of a few Board Meetings were entered in the Minutes Book beyond the prescribed timeline due to administrative and operational constraints and confirms that such instances shall not recur in future.

During the course of audit, it was observed that the Company had not obtained the requisite trade license(s) / shop and establishment registrations as applicable further management commented:

The Management acknowledges that the Company has not obtained certain trade licenses and registration under the Shops and Establishments Act, wherever applicable, due to oversight and administrative reasons and the Management also undertakes to strengthen its compliance monitoring mechanism to ensure timely identification and completion of statutory registrations and licenses in future.

During the period under review, the Company was required to file the Foreign Liabilities and Assets (FLA) Return with the Reserve Bank of India under the provisions of the Foreign Exchange Management Act, 1999. However, the Company has not filed the said return within the prescribed timeline further the management commented:

The Management acknowledges that the Company could not file the Foreign Liabilities and Assets (FLA) Return within the prescribed timeline / failed to file the same due to inadvertent oversight and administrative reasons. MANAGEMENT DISCUSSION AND ANALYSIS REPORT

This Management Discussion and Analysis Report has been prepared in compliance with the requirements of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015. The Report provides an overview of the Company's expectations and projections relating to its growth strategy, product development initiatives, market position, expenditures, and financial performance.

Certain statements contained in this Management Discussion and Analysis Report are forward-looking statements that involve various risks and uncertainties. Actual results, performance, or achievements may differ materially from those expressed or implied in such forward-looking statements due to changes in underlying assumptions, future developments, information, or events. The Company does not undertake any obligation to update or revise such forward-looking statements, except as may be required under applicable laws and regulations.

Global Economy

The global economy remained resilient during Financial Year 2025-26 despite a challenging operating environment characterised by geopolitical tensions, evolving trade policies, persistent policy uncertainty and disruptions in global supply chains. While inflationary pressures moderated across several economies and financial conditions gradually improved, the pace of economic recovery remained uneven across regions.

Global economic activity was supported by resilient domestic demand, continued investment in technology and infrastructure, and the adaptability of businesses to changing trade and policy conditions. However, heightened geopolitical tensions, increasing trade restrictions and volatility in commodity and energy prices continued to pose challenges to global growth and investment sentiment.

The global outlook for 2026 remains subject to considerable uncertainty. Global growth is projected at 3.1% in 2026 and 3.2% in 2027. The conflict in the Middle East may result in higher energy prices, renewed inflationary pressures and tighter financial conditions. Global growth is also projected to slow to 2.5% in 2026 before improving to 2.8% in 2027-28.

The United States economy is projected to remain resilient, supported by consumer spending, investment and a relatively stable labour market. However, trade policy changes, higher energy costs and regulatory and financial uncertainties may moderate the pace of growth. The Euro Area is projected to continue experiencing subdued economic activity amid structural challenges, energy-related pressures and relatively weak external demand.

China's economy is projected to continue navigating structural adjustments, including stress in the property sector, subdued consumer sentiment and changing external trade conditions. The evolution of global trade policies and tariff measures may continue to influence China's export-oriented sectors and international supply chains.

The economies of the Gulf Cooperation Council are projected to continue benefiting from infrastructure investment and economic diversification initiatives. Investments in non-oil sectors, including infrastructure, manufacturing, tourism, technology and clean energy, are expected to strengthen the region's economic base and reduce dependence on hydrocarbons.

The global business environment is therefore expected to remain dynamic, with opportunities arising from technological advancement, infrastructure development, supply-chain diversification and emerging markets, while geopolitical developments, energy prices, protectionist trade measures and currency volatility remain important risk factors.

Outlook

Global growth is projected to remain resilient at 3.3% in 2026 and 3.2% in 2027, broadly in line with 2025 levels, despite moderating momentum in high-tech sectors and lingering trade uncertainties. Inflation is expected to ease from 4.1% in 2025 to 3.4% by 2027. Advanced economies will witness steady but moderate growth, while emerging markets, including India, will continue to drive global expansion, supported by structural strengths and policy support. The situation in West Asia remains dynamic, set against an evolving global economic landscape. Encouragingly, the resilience demonstrated by global markets and economies provides confidence in their ability to adapt and navigate emerging challenges effectively.

Indian economy

India continues to stand out as one of the world's fastest-growing major economies with GDP growth for FY 2025-26 was 7.6%, driven by the twin engines of consumption and investment. Strong domestic demand, supported by rising purchasing power, stable employment and healthy rural and urban consumption, remains the cornerstone of growth. Investment activity has also strengthened, reflecting improving business confidence and sustained public capital expenditure. While global uncertainties and trade-related challenges persist, India has demonstrated resilience by advancing structural reforms, enhancing ease of doing business and strengthening economic fundamentals. Inflation remains largely contained, and balance sheets across households, corporates and banks are robust.

Outlook

FY 2026-27 is expected to mark a phase of steady consolidation, supported by resilient domestic demand and strengthening investment momentum. While global uncertainties persist, moderating inflation and more accommodative monetary conditions provide a supportive backdrop. Continued policy reforms, improved ease of doing business and ongoing trade negotiations are likely to ease external pressures. With healthy balance sheets and sustained public investment, the Indian economy remains well-positioned to navigate global volatility, with GDP growth projected at ~7.2%, reflecting a stable and optimistic growth outlook.

METALS AND STEELS:

The Indian metals and mining industry continues to play a critical role in the country's economic and industrial development by providing essential raw materials to key sectors such as infrastructure, construction, automotive, power, engineering, manufacturing and renewable energy. India's substantial reserves of iron ore, bauxite, chromite, manganese and other minerals provide a strong resource base for the continued development of the metals and mining sector.

During FY 2025–26, the Indian steel industry continued to witness healthy growth, supported by sustained domestic demand, increased infrastructure spending, urbanisation and expansion in construction and automotive activities. The Government's continued focus on infrastructure development, transportation networks, housing, industrial corridors and other capital-intensive projects remained important drivers of steel consumption.

The performance of the Indian steel sector remained resilient during the year despite volatility in global commodity markets, fluctuations in raw-material prices and developments in international trade. During April–June 2025, crude steel production in India stood at approximately 40.31 million tonnes, registering growth of 10.4% over the corresponding period of the previous year. Finished steel production during the period stood at approximately 38.57 million tonnes, while finished steel consumption was approximately 38.34 million tonnes, reflecting continued strength in domestic demand.

India's steel industry also benefits from the availability of domestic iron ore and other mineral resources. The Ministry of Mines has reported that the estimated value of metallic mineral production during FY 2025–26 was approximately ₹1,57,415 crore, representing an increase of around 13.66% over the previous year. Iron ore continued to be the dominant metallic mineral, contributing approximately 69.64% of the total value of metallic mineral production. Bauxite production was estimated at 25.78 million tonnes during FY 2025–26, registering growth of approximately 4.18% over the previous year.

The availability of domestic mineral resources provides India with a significant competitive advantage and supports the development of an integrated metals value chain. India remains substantially self-sufficient in several important minerals, including iron ore, bauxite and chromite. This domestic resource base helps reduce dependence on imports for key raw materials and provides opportunities for further value addition through beneficiation, processing and downstream manufacturing.

Demand Drivers

The outlook for the Indian steel and metals industry remains closely linked to the growth of infrastructure and industrial activity. Government expenditure on roads, railways, ports, airports, urban infrastructure and housing is expected to continue supporting steel demand. In addition, the expansion of the automotive, engineering, renewable energy, electrical equipment and manufacturing sectors is expected to create incremental demand for both conventional and value-added steel products.

The power, transmission and renewable energy sectors are also significant consumers of metals, particularly aluminium and steel. Aluminium demand is supported by applications in power transmission, automotive and transportation, construction, packaging, machinery, electronics and renewable energy.

Government Initiatives and Industry Outlook

The Government of India continues to focus on strengthening domestic steel production, improving product quality, promoting value-added and specialised steel products, encouraging technological advancement and reducing dependence on imports. The National Steel Policy, 2017 envisages substantial expansion in India's steel-making capacity and production by 2030–31, reflecting the long-term strategic importance of the sector to the Indian economy.

The medium- to long-term outlook for the Indian metals and steel industry remains positive, supported by economic growth, infrastructure development, urbanisation, rising per-capita consumption and increasing manufacturing activity. The sector is also expected to benefit from greater emphasis on

domestic value addition, downstream processing, technological upgradation and the development of higher-grade and specialised steel products.

At the same time, the industry remains exposed to certain risks, including fluctuations in iron ore, coal, energy and other input costs, global steel prices, international trade measures, exchange-rate movements, environmental and regulatory requirements and cyclicalities in end-user industries. Increasing focus on decarbonisation and energy efficiency is also expected to influence investment requirements and production technologies across the industry.

Overall, India's strong mineral resource base, expanding domestic steel consumption, infrastructure-led economic growth and favourable long-term demand fundamentals provide a supportive environment for the continued growth of the metals and steel industry.

Market Size

- In FY26, crude steel production in India stood at 168.4 MT, while finished steel production reached 160.90 MT.
- In FY27 (April-May 2026) the production of crude steel stood at 28 MT and finished steel stood at 27.4 MT.
- In FY26 (April–December 2025), India's total steel production stood at 5,983 thousand tonnes (provisional), as compared to 6,261 thousand tonnes in FY25, registering a decline.
- India is expected to surpass its steel production capacity target of 300 MT by 2030, reaching an estimated 330 MT.
- India is the second-largest producer of aluminium globally. The production of primary aluminium reached 7.07 lakh ton (LT) in FY26 (April-May 2025) from 6.98 LT in FY25 (April-May 2024). Iron Ore production for the month of October 2025 is 24.8 million tonnes, as compared to 22.9 million tonnes for October 2024. The cumulative production of Iron Ore for FY26 (April-October 2025) is 156.6 million tonnes as compared to 158.4 million tonnes in FY25 (April-October 2024).
- The estimated value of mineral production for FY26 is Rs. 1,71,460 crore (US \$18.67 billion), as against Rs. 1,52,431 crore (US\$ 17.49 billion) in FY25.
- India's copper demand is expected to grow about 7% annually, led by renewable energy expansion, electric vehicles, and infrastructure projects including industrial corridors, national highways, and the Housing for All programme, with domestic consumption already exceeding 7,50,000 tonnes against production of about 5,55,000 tonnes with demand projected to double by 2030.
- GVA at basic prices from mining and quarrying stood at Rs. 5,08,554 crore (US 55.38 billion) in 2025–26 (FAE), as compared to Rs. 5,40,788 crore (US\$ 62.05 billion) in 2024-25 (P), as per the Ministry of Statistics.
- The construction sector's Gross Value Added (GVA) at current prices was estimated at Rs. 27,99,847 crore (US\$ 316.83 billion) for FY26 (FAE) against Rs. 26,27,009 crore (US\$ 310.67 billion) for FY25 (PE).
- The combined Index of Eight Core Industries (ICI) in October 2025 has remained unchanged at 162.4 (provisional) as compared to the Index in October 2024.

Investments/ Developments

Some of the investments/ developments in the Metals & Mining sector in the recent past are as follows:

- On February 26, 2026, NMDC's R&D Centre signed an MoU with IIT Hyderabad to advance indigenous mineral processing, green steelmaking, critical mineral extraction, AI-enabled

mining and Mining 4.0 technologies, strengthening India's metals and mining innovation and sustainable development.

- India is accelerating critical minerals exploration and mining infrastructure under Atmanirbhar Bharat to strengthen supply chains for EVs, renewable energy and defence, while, on May 10, 2026, experts highlighted sustainable CSR initiatives supporting the metals and mining sector.
- Further developments noted on February 18, 2026 indicate that the industry is undergoing structural transformation through policy support such as the Critical Minerals framework, improved regulatory mechanisms, and growing global and domestic investments. The sector is also focusing on digitalisation, ESG practices, and supply chain strengthening, positioning it as a key driver of long-term economic growth and investment expansion.
- India's metals and mining sector is entering a strong growth phase, supported by government reforms, accelerated mine auctions, and increased domestic exploration, as highlighted on November 6, 2025. The sector is also benefiting from rising demand for critical minerals linked to the global energy transition, alongside a push for mineral self-reliance and higher private sector participation.
- As of October 2025, non-fossil fuel sources now contribute 250.6 GW (49%) of total capacity, including 200.29 GW renewable and 8.78 GW nuclear.
- During the earnings call for Q2 FY26, Tata Steel plans a 7-7.5 million tonne capacity expansion across its Indian operations, with major brownfield projects at Kalinganagar, Neelachal, Meramandali, Ludhiana and Gamharia moving through planning and approval stages.
- India plans to train 5.7 million workers by 2030 in the mining sector under the National Critical Mineral Mission to boost domestic critical mineral production and cut import dependence.
- As of August 2025, JSW Steel and Japan's JFE Steel are planning to jointly invest Rs. 5,845 crore (US\$ 682 million) to expand capacity for cold-rolled grain-oriented electrical steel (CRGO) to 3,50,000 tonnes per annum by FY28 by scaling up the Nashik plant from 50,000 to 2,50,000 TPA and increasing the Vijayanagar unit's capacity to 1,00,000 TPA.
- On July 7, 2025, Tata Steel signed a Memorandum of Understanding with Australia's InQuik Group to bring modular bridge construction technology to India, using prefabricated steel formwork filled with concrete on site to enable faster, cost-effective, climate resilient and scalable bridge infrastructure, especially useful in remote regions.
- NALCO produced 37,736 Metric Tonne of Aluminium and sold 30,595 Metric Tonne of Aluminium metal in April, 2026.
- BALCO produced 50,994 Metric Tonne of Aluminium and sold 42,322 Metric Tonne of Aluminium metal in April, 2026.
- Vedanta Limited (Aluminium) produced 1,52,638 Metric Tonne of Aluminium and sold 1,43,666 Metric Tonne of Aluminium metal in April, 2026.
- In June 2025, India and Australia strengthened their Critical Minerals Investment Partnership to co-invest in lithium and cobalt projects and build resilient clean-energy supply chains.
- Between April 2000-March 2026, FDI inflows in the metallurgical industry stood at Rs. 1.20 lakh crore (US\$ 19.3 billion), followed by the mining Rs. 21,794.45 crore (US\$ 3.54 billion), diamond & gold ornaments Rs. 9,962.78 crore (US\$ 1.54 billion), and coal production Rs. 119.19 crore (US\$ 27.73 million).
- India's steel exports in July 2025 saw a higher share from Belgium, Italy, Spain, Taiwan, Bulgaria, the US and Qatar, while the share of the UAE, Nepal and Portugal declined compared to July 2024.
- With the fifth-largest coal reserves and as the second-largest consumer, coal remains crucial for India, contributing 55% to the national energy mix and fuelling over 74% of total power generation as of April 2025.
- On March 28, 2025, AM/NS India has secured 890 hectares of land in Rajayyapeta, Anakapalli district, Andhra Pradesh for a new integrated steel mill with planned capacity of about 7 MTPA of crude steel, expanding beyond its Hazira operations to meet rising domestic demand.
- In January 2025, the Ministry of Steel has introduced the PLI Scheme 1.1 for specialty steel, covering five product categories, which aligns with the existing PLI Scheme. This initiative aims to encourage greater participation in response to industry requests for relaxation. The PLI

Scheme I.I will be open for applications from January 6 to January 31, 2025, and will be implemented from FY26 to FY30.

- India and Kazakhstan have launched IREUK Titanium Limited, a joint venture to produce Titanium Slag in India, marking India's first venture in Central Asia. The company will convert low-grade Ilmenite into high-grade titanium feedstock, aiming to enhance the titanium value chain in India and create jobs in Odisha.
- Southeastern Coalfields Limited (SECL), a subsidiary of Coal India in Chhattisgarh, has reached a milestone with its Gevra and Kusunda coal mines ranking 2nd and 4th on WorldAtlas.com's list of the world's largest coal mines. Located in Korba district, these mines together produce over 100 million tons of coal annually, accounting for about 10% of India's total coal production.
- India is experiencing a construction boom driven by a growing housing economy and significant government infrastructure investments. The country is projected to become the third-largest construction market in the world, following China and the US, by 2025.

Government Initiatives

The Government of India has adopted few initiatives in the recent past, some of these are as follows:

- On April 9, 2025, the Government launched the National Critical Mineral Mission (NCMM) to strengthen India's critical minerals sector through 1,200 exploration projects, faster approvals, private participation and processing infrastructure, boosting self-reliance and domestic mining capabilities.
- The Union Budget 2026–27, presented on February 1, 2026, outlines several government initiatives to strengthen India's metals and mining sector as part of a broader push for industrial growth and self-reliance. Key measures include the proposal to develop dedicated mineral corridors in resource-rich states such as Odisha and Tamil Nadu, along with import duty exemptions on capital goods for critical mineral processing, aimed at boosting domestic production and value addition. The budget also emphasises manufacturing expansion, export promotion, and supply chain resilience, with a strong focus on critical minerals and downstream industries. These initiatives are expected to generate large-scale employment, enhance capacity creation, and position the sector as a key driver of economic growth amid evolving global supply chains.
- On November 26, 2025, the Union Cabinet chaired by Prime Minister Mr. Narendra Modi approved a Rs. 7,280 crore (US\$ 809.8 million) "Scheme to Promote Manufacturing of Sintered Rare Earth Permanent Magnets (REPM)", marking a major positive step for India's metals and mining ecosystem. The initiative aims to establish 6,000 MTPA of integrated REPM manufacturing capacity, creating a complete domestic value chain from rare earth oxides to finished magnets, thereby strengthening self-reliance and positioning India as a key player in the global market. The scheme supports critical sectors such as electric vehicles, renewable energy, aerospace and defence, while also reducing import dependence, generating employment, and reinforcing supply chains in line with the Atmanirbhar Bharat vision and India's Net Zero 2070 goals.
- In August 2025, the Commerce Ministry, via the DGTR, has recommended a three-year safeguard duty on imports of certain flat steel products, 12% in year one, 11.5% in year two, and 11% in year three, to protect domestic producers from a sharp import surge.
- India launched the seven-year National Critical Mineral Mission in January 2025 with a proposed Rs. 16,300 crore (US\$ 1.9 billion) outlay and an expected Rs. 18,000 crore (US\$ 2.1 billion) investment by Public Sector Undertakings and other stakeholders to secure key minerals for clean energy and advanced technologies.
- By May 27, 2025, the Centre had successfully auctioned a cumulative 34 critical/strategic mineral blocks across five tranches out of 55 offered, including the first ever potash block; these include both Mining Leases (ML) and Composite Licences (CL) across multiple states.

- In January 2025, the Cabinet approved the National Critical Mineral Mission to fund exploration-to-recycling, with multi year budgetary support and complementary PSU investments.
- In the Union Budget 2025-26, capital investment outlay for infrastructure is being increased by 11.1% to Rs. 11.2 lakh crore (US\$ 129.0 billion). To encourage higher private participation, the government has proposed various measures.
- In February 2024, the Union Cabinet approved the amendment to the Mines and Minerals (Development and Regulation) Act, 1957 specifying royalty rates for 12 critical minerals, thus completing the rationalization process for all 24 strategic minerals. This move aims to streamline the mining sector and auction processes, aligning with recent amendments to the MMDR Amendment Act, 2023.
- In December 2023, the Ministry of Mines proposed capping performance security and upfront amounts for mining critical minerals to attract more bidders. Currently based on a percentage of the Value of Estimated Resources (VER), the move aims to reduce barriers to participation in auctions and expedite the process for mining leases.
- In October 2023, the Union Cabinet approved the amendment of the Second Schedule of the Mines and Minerals (Development and Regulation) Act, 1957, specifying royalty rates for three critical minerals: Lithium, Niobium, and Rare Earth Elements (REEs) paving the way for the auctioning of blocks for these minerals, as outlined in the MMDR Amendment Act, 2023.
- The government plans to monetize assets worth Rs. 28,727 crore (US\$ 3.68 billion) in the mining sector over 2022-25.
- In 2022, PLI Scheme for domestic production of specialty steel has been approved with an outlay of Rs. 6,322 crore (US\$ 762.4 million) by the Cabinet.
- Import duty on Anthracite/Pulverized Coal Injection (PCI) coal, Coke, and Semi-coke and Ferronickel were reduced to zero.
- Export duty on Iron ores/ concentrates and iron ore pellets was raised to 50% and 45%, respectively.
- In addition, 15% export duty was imposed on pig iron and several steel products.
- The Ministry of Mines of the Government of India has signed MoUs with different nations.
- The National Steel Policy aims to boost per capita steel consumption to 160 kgs by 2030-31. The government has a fixed objective of increasing rural consumption of steel from the current 19.6 kgs per capita to 38 kgs per capita by 2030-31.

HMS (Heavy Melting Scrap), aluminum scrap, stainless steel scrap, copper scrap, brass scrap, etc. The company also deals in ferrous Scrap, non-ferrous Scrap and reusable items. It procures metal scrap originating from USA, West African and European countries, and sells these products in the domestic market all over India.
2. Petrochemicals – The Company also operates in the trading, wholesaling, distribution and indenting business of base oil variants to refineries along with supply of petrochemicals to industries. The petroleum products traded / distributed by the Company are Group I, II and III variants for automobiles lubricants and different industrial purposes, Granular & Formed Sulphur used in phosphate based industrial and consumer industry sectors and Aromatics – Benzene, Toluene.

We have developed a sustainability mission for our company which can be briefed in three words (reduce-reuse-recycle).

BUSINESS OVERVIEW

The total standalone turnover including other income for the year 2025-26 stood at Rs. 5163.97Lacs as compared to Rs. 6983.72 Lacs for the year 2024-25. Notes to Standalone financial statements for the year ended 31st March, 2026

Note No. 1: - STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

1 Corporate Information

AKG Exim Limited is a Public listed company domiciled in India and incorporated under the provisions of the Companies Act, 1956 /Companies Act, 2013. The Company is engaged in the business of Import / Export, Trading of Metals Scrap, Petrochemicals, etc. These financial statements have been approved by way of resolution passed by Board of Directors on 27th May, 2026.

2 Basis of preparation

A Statement of Compliance

The company's financial statements are prepared complying in all material respects with the Indian Accounting Standards (IND AS) notified under Section 133 of the Company Act 2013, read together with Companies (Indian Accounting Standards) Rules, 2015, as amended from time to time and other relevant provisions of the Act, on an accrual basis.

B Basis of measurement

The financial statements are prepared on Historical Cost basis except for certain financial assets and liabilities that are measured at fair value (Refer accounting policy regarding Financial Instruments). The accounting policies not specifically referred to otherwise, are consistent and in consonance with generally accepted accounting principles. All income and expenditure are being accounted for on accrual basis.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

C Functional and Presentation currency

These financial statements are presented in Indian Rupees (INR), which is the Company's functional currency. All financial information presented in INR has been rounded to the nearest lakhs (upto two decimals), except as stated otherwise.

D Use of Estimates

In preparing Company's financial statements in conformity with accounting principles generally accepted in India, management is required to make estimates and assumptions that affect the reported amount of assets and liabilities and the disclosure of contingent liabilities at the date of the financial statements and reported amount of revenues and expenses during the reporting period. Actual results could differ from those estimates. Any revision to accounting estimates is recognized in the period in which the same is determined.

E Current and non-current classification

The Company presents assets and liabilities in the balance sheet based on current/non-current classification.

An asset is current when it is:

- Expected to be realized or intended to sold or consumed in normal operating cycle;
- Held primarily for the purpose of trading;
- Expected to be realized within twelve months after the reporting period; or
- Cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current.

A liability is current when:

- It is expected to be settled in normal operating cycle;
- It is held primarily for the purpose of trading;
- It is due to be settled within twelve months after the reporting period; or
- There is no unconditional right to defer settlement of the liability for at least twelve months after the reporting period.

All other liabilities are classified as non-current.

3 Significant accounting policy

A Property Plant & Equipment

A.1 Initial recognition and measurement

An item of property, plant and equipments recognized as an asset if and only if it is probable that future economic benefits associated with the item will flow to the company and the cost of the item can be measured reliably.

Items of Property, Plant and Equipment are measured at cost less accumulated depreciation/amortization and accumulated impairment losses. Cost includes expenditure that is directly attributable to bringing the asset, inclusive of non-refundable taxes & duties, to the location and condition necessary for it to be capable of operating in the manner intended by management.

When parts of an item of property, plant and equipment have different useful lives, they are recognized separately.

Items of spare parts, stand-by equipment and servicing equipment which meet the definition of Property, Plant and Equipment are capitalized.

Property, Plant and Equipments which are not ready for intended use as on the date of Balance Sheet are disclosed as 'Capital Work-In-Progress'.

A.2. Subsequent costs

Subsequent expenditure is recognized as an increase in the carrying amount of the asset when it is probable that future economic benefits deriving from the cost incurred will flow to the enterprise and the cost of the item can be measured reliably. The cost of replacing part of an item of property, plant and equipment is recognized in the carrying amount of the item if it is probable that the future economic benefits embodied within the part will flow to the Company and its cost can be measured reliably. The carrying amount of the replaced part is derecognized. The costs of the day-to-day servicing of Property, Plant and Equipment are recognized in profit or loss as incurred.

A.3. Derecognition

Property, Plant and Equipment are derecognized when no future economic benefits are expected from their use or upon their disposal. Gains and losses on disposal of an item of property, plant and equipment are determined by comparing the proceeds from disposal with the carrying amount of property, plant and equipment, and are recognized in the statement of profit and loss.

A.4. Depreciation/amortization

Depreciable amount for assets is the cost of an asset, or other amount substituted for cost, less its estimated residual value. Depreciation on PPE has been provided on the written down value method as per the useful life prescribed in Schedule II to the Companies Act, 2013.

Depreciation on additions to/deductions from property, plant and equipment during the year is charged on pro-rata basis from/up to the date on which the asset is available for use/disposed.

Depreciation on property, plant and equipment except leasehold land is provided on their estimated useful life as prescribed by Schedule II of Companies Act, 2013.

B Capital work-in-progress

The cost of self-constructed assets includes the cost of materials & direct labour, any other costs directly attributable to bringing the assets to the location and condition necessary for it to be capable of operating in the manner intended by management and borrowing costs.

Expenses directly attributable to construction of property, plant and equipment incurred till they are ready for their intended use are identified and allocated on a systematic basis on the cost of related assets.

C Intangible assets and intangible assets under development

C.1 Initial recognition and measurement

An intangible asset is recognized if and only if it is probable that the expected future economic benefits that are attributable to the asset will flow to the company and the cost of the asset can be measured reliably.

Intangible assets that are acquired by the Company, which have finite useful lives, are recognized at cost. Subsequent measurement is done at cost less accumulated amortization and accumulated impairment losses. Cost includes any directly attributable incidental expenses necessary to make the assets ready for its intended use.

Notes to the financial statements for the year ended 31st March, 2026 (Contd.)

Expenditure on development activities is capitalized only if the expenditure can be measured reliably, the product or process is technically and commercially feasible, future economic benefits are probable and the Company intends to and has sufficient resources to complete development and to use or sell the asset.

Expenditure incurred which are eligible for capitalizations under intangible assets are carried as intangible assets under development till they are ready for their intended use.

C.2 Subsequent costs

Subsequent expenditure is recognized as an increase in the carrying amount of the asset when it is probable that future economic benefits deriving from the cost incurred will flow to the enterprise and the cost of the item can be measured reliably.

C.3 Derecognition

An intangible asset is derecognized when no future economic benefits are expected from their use or upon their disposal. Gains and losses on disposal of an item of intangible assets are determined by comparing the proceeds from disposal with the carrying amount of intangible assets and are recognized in the statement of profit and loss.

C.4 Amortization

Intangible assets having definite life are amortized on straight line method in their useful lives. Useful life of computer software is estimated at Six years.

D Inventories

Inventories are valued at the lower of cost (e.g. on FIFO / weighted average basis) and the net realisable value after providing for obsolescence and other losses, where considered necessary. Cost includes all charges in bringing the goods to the point of sale, including STT, Cess and other levies.

E Cash and Cash Equivalents

Cash and cash equivalent in the balance sheet comprise cash at banks and cash on hand and short-term deposits with an original maturity of three months or less, which are subject to insignificant risk of change in value.

F Financial instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

F.1 Financial assets:

F.1.1 Initial recognition and measurement

All financial assets are recognized initially at fair value plus or minus, in the case of financial assets not recorded at fair value through profit or loss, transaction costs are attributable to the acquisition or issue of the financial asset, otherwise charged to Statement of Profit & Loss.

F.1.2 Subsequent measurement

Financial assets are subsequently classified and measured at:

- Financial assets at amortised cost
- Financial assets at fair value through profit and loss (FVTPL)
- Financial assets at fair value through other comprehensive income (FVOCI).

a) Trade Receivables

Trade receivables are initially recognised at fair value. Subsequently, these assets are held at amortised cost, using the effective interest rate (EIR) method net of any expected credit losses wherever applicable. The EIR is the rate that discounts estimated future cash income through the expected life of financial instrument.

b) Debt instruments

i) Measured at amortized cost

A 'debt instrument' is measured at the amortized cost if both the following conditions are met:

- (a) The asset is held within a business model whose objective is to hold assets for collecting contractual cash flows, and
- (b) Contractual terms of the asset give rise on specified dates to cash flows that are solely payments of principal and interest (SPPI) on the principal amount outstanding.

Notes to the financial statements for the year ended 31st March, 2026 (Contd.)

After initial measurement, such financial assets are subsequently measured at amortized cost using the EIR method. Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortization is included in finance income in the profit or loss. The losses arising from impairment are recognized in the profit or loss.

ii) **Measured at FVTOCI (Fair Value through OCI)**

A 'debt instrument' is classified as at the FVTOCI if both of the following criteria are met:

- (a) The objective of the business model is achieved both by collecting contractual cash flows and selling the financial assets, and
- (b) The asset's contractual cash flows represent SPPL.

Debt instruments included within the FVTOCI category are measured initially as well as at each reporting date at fair value. Fair value movements are recognized in the OCI. However, the Company recognizes interest income, impairment losses & reversals and foreign exchange gain or loss in the profit and loss. On derecognition of the asset, cumulative gain or loss previously recognized in OCI is reclassified from the equity to profit and loss. Interest earned whilst holding FVTOCI debt instrument is reported as interest income using the EIR method.

iii) **Measured at FVTPL (Fair value through profit or loss)**

FVTPL is a residual category for debt instruments. Any debt instrument, which does not meet the criteria for categorization as at amortized cost or as FVTOCI, is classified as at FVTPL.

In addition, the Company may elect to classify a debt instrument, which otherwise meets amortized cost or FVTOCI criteria, as at FVTPL. However, such election is allowed only if doing so reduces or eliminates a measurement or recognition inconsistency (referred to as 'accounting mismatch'). Debt instruments included within the FVTPL category are measured at fair value with all changes recognized in the profit and loss.

c) **Equity Instruments:**

All investments in equity instruments in entities other than subsidiaries and joint ventures are measured at fair value. Equity instruments if held for trading are classified as at FVTPL. For all other equity instruments, the Company decides to classify the same either as at FVTOCI or FVTPL. The Company makes such election on an instrument by instrument basis. The classification is made on initial recognition and is irrevocable. Investments in subsidiaries and Joint Venture are carried at cost. The cost comprises price paid to acquire investment and directly attributable cost.

If the company decides to classify an equity instrument as at FVTOCI, then all fair value changes on the instruments, excluding dividends, are recognized in the OCI. There is no recycling of the amounts from OCI to P&L, even on sale of investment as the company transfers cumulative gain or loss within the equity.

Equity instruments if classified as FVTPL category are measured at fair value with all changes recognized in the profit and loss.

F.1.3 **Derecognition**

A financial asset (or, where applicable, a part of a financial asset or part of a Company of similar financial assets) is primarily derecognized (i.e. removed from the Company's balance sheet) when:

- The contractual rights to receive cash flows from the asset have expired, or
- The Company has transferred its contractual rights to receive cash flows from the asset.

F.1.4 **Impairment of Financial Asset**

Expected credit losses are recognized for all financial assets subsequent to initial recognition in Statement of Profit & Loss other than financial assets in FVTPL category.

For recognition of impairment loss on financial assets other than Trade receivables, the company determines whether there has been a significant increase in the credit risk since initial recognition. If credit risk has not increased significantly, 12-month ECL is used to provide impairment loss. However, If credit risk is increased significantly, lifetime ECL is used.

If, in a subsequent period, credit quality of the instrument improves such that there is no longer a significant increase in credit risk since initial recognition, then the entity reverts to recognising impairment loss allowance based on 12- Month ECL.

For trade receivables Company applies 'simplified approach' which requires expected lifetime losses to be recognised from initial recognition of the receivables. The Company uses historical default rates to determine impairment loss on the portfolio of trade receivables. At every reporting date these historical default rates are reviewed and changes in the forward looking estimates are analysed.

For other assets, the Company uses 12 month ECL to provide for impairment loss where there is no significant increase in credit risk. If there is significant increase in credit risk full lifetime ECL is used.

Notes to the financial statements for the year ended 31st March, 2026 (Contd.)

F.2 Financial liabilities

F.2.1 Initial recognition and measurement

All financial liabilities are recognized at fair value and in case of loans, net of directly attributable cost. Fees of recurring nature are directly recognised in the Statement of Profit and Loss as finance cost.

F.2.2 Subsequent measurement

Financial liabilities are carried at amortized cost using the effective interest method. Amortized cost is calculated by taking into account any discount or premium on acquisition and any material transaction that are any integral part of the EIR. For trade and other payables maturing within one year from the balance sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

Financial liabilities carried at fair value through profit or loss are measured at fair value with all changes in fair value recognised in the Statement of Profit and Loss.

F.2.3 Derecognition

A financial liability is derecognized when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognized in the statement of profit or loss.

F.3 Derivative financial instruments

The Company uses forwards to mitigate the risk of changes in exchange rates. Such derivative financial instruments are initially recognised at fair value on the date on which a derivative contract is entered into and are also subsequently measured at fair value. Derivatives are carried as financial assets when the fair value is positive and as financial liabilities when the fair value is negative. Any gains or losses arising from changes in the fair value of derivatives are taken directly to Statement of Profit and Loss.

G Fair value measurement

The Company measures financial instruments, such as derivatives at fair value at each balance sheet date. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either:

- In the principal market for the asset or liability, or
- In the absence of a principal market, in the most advantageous market for the asset or liability.

The principal or the most advantageous market must be accessible by the company. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest. A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use. The company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximizing the use of relevant observable inputs and minimizing the use of unobservable inputs. All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorized within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1 – Quoted (unadjusted) market prices in active markets for identical assets or liabilities

Level 2 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable

Level 3 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable.

For assets and liabilities that are recognized in the financial statements on a recurring basis, the company determines whether transfers have occurred between levels in the hierarchy by re-assessing categorization (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period. The Company determines the policies and procedures for both recurring fair value measurement, such as derivative instruments and unquoted financial assets measured at fair value, and for non-recurring measurement, such as assets held for distribution in discontinued operations.

Notes to the financial statements for the year ended 31st March, 2026 (Contd.)

F Impairment of Non-Financial Assets

The Company, in accordance with the Indian Accounting Standard (Ind AS) 36 "Impairment of Assets", has adopted the practice of assessing at each Balance Sheet date whether there is any indication that an asset may be impaired. If any such indication exists, then the company provides for the loss for impairment of Assets after estimating the recoverable amount of the assets.

G Provisions, Contingent Liabilities and Contingent Assets

Provision are measured at the Present value of the management's best estimate of the expenditure required to settle the present obligation at the end of reporting period. Provisions involving substantial degree of estimation in measurement are recognized when there is a present obligation as a result of past events and it is probable that there will be an outflow of resources.

Contingent liabilities are disclosed only when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events which is not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle the obligation or estimate of the amount cannot be measured reliably.

No contingent asset is recognized but disclosed by way of notes to accounts only when its recognition is virtually certain.

H Revenue Recognition

Revenue is recognized to the extent that it is probability that the economic benefits will flow to the company and the revenue can be reliably measured. The Following specific criteria must also be met before revenue is recognized.

Shares Purchases / Sales in Capital Market Segment has been taken on absolute basis. Derivative Segments Transactions has been taken on difference bill basis.

Dividend income is recognized when the right to receive the income is established.

Interest income is recognised, when no significant uncertainty as to measurability or collectblitiy exists, on a time proportion basis taking into account the amount outstanding and the applicable interest rate, using the effective interest rate method (EIR).

I Foreign Currency Conversions/Transactions

Foreign Currency Transactions are recorded at the exchange rates prevailing on the date of the transactions. Gains and losses arising out of subsequent fluctuations are accounted for on actual payments or realisations as the case may be. Monetary assets and liabilities denominated in foreign currency as on Balance Sheet date are translated into functional currency at the exchange rates prevailing on that date and Exchange differences arising out of such conversion are recognised in the Statement of Profit and Loss.

J Income Taxes

Income tax expense for the year comprises of current tax and deferred tax. It is recognised in the Statement of Profit and Loss except to the extent it relates to any business combination or to an item which is recognised directly in equity or in other comprehensive income.

a) Current Tax

Current tax expense is made on the basis of estimated taxable income for the current accounting period in accordance with the provisions of Income Tax Act, 1961 and judicial interpretations thereof as at the Balance Sheet date and takes into consideration various deductions and exemptions to which the Company is entitled to as well as the reliance placed by the Company on the legal advices received by it.

b) Deferred Tax

Deferred tax charge or credit reflects the tax effects of temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. The deferred tax charge or credit and the corresponding deferred tax liabilities or assets are recognized using the tax rates that have been enacted or substantively enacted by the Balance Sheet date. Deferred tax assets are reviewed at each Balance Sheet date and are written-down or written-up to reflect the amount that is reasonably certain (as the case may be) to be realized.

Deferred tax assets and deferred tax liabilities are offset when there is a legally enforceable right to set off assets against liabilities representing current tax and where the deferred tax assets and the deferred tax liabilities relate to taxes on income levied by the same governing taxation law.

Deferred tax assets are recognised for all deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

Notes to the financial statements for the year ended 31st March, 2026 (Contd.)

K Employee Benefits

Employees benefits include provident fund, superannuation fund, employee state insurance scheme, gratuity fund, compensated absences, long service awards and post-employment medical benefits. Retirement benefits are accounted for as and when paid.

Any actuarial gains or losses pertaining to components of re-measurements of net defined benefit liability/(asset) are recognized in OCI in the period in which they arise.

L Borrowing Cost

General and Specific Borrowing Cost that are directly attributable to the acquisition or construction or production of qualifying assets are capitalized as part of the cost of such assets upto the date when such assets are ready for intended use. Qualified assets are assets that necessarily take a substantial period of time to get ready for their intended use or sale.

Other borrowing costs are charged as expenses in the year in which they are incurred.

Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing cost eligible for capitalisation.

M Earning Per Share

Basic Earning Per Share is calculated by dividing the net profit or loss for the period attributable to equity shareholders by weighted average number of equity shares outstanding during the period.

For the purpose of calculating diluted earnings per share, net profit after tax during the year and the weighted average number of shares outstanding during the year are adjusted for the effect of all dilutive potential equity shares.

N Leases

As Lessee

Accounting for finance leases

The Company, as a lessee, recognises a right-of-use asset and a lease liability for its leasing arrangements, if the contract conveys the right to control the use of an identified asset.

The contract conveys the right to control the use of an identified asset, if it involves the use of an identified asset and the Company has substantially all of the economic benefits from use of the asset and has right to direct the use of the identified asset. The cost of the right-of-use asset shall comprise of the amount of the initial measurement of the lease liability adjusted for any lease payments made at or before the commencement date plus any initial direct costs incurred. The right-of-use assets is subsequently measured at cost less any accumulated depreciation, accumulated impairment losses, if any and adjusted for any remeasurement of the lease liability. The right-of-use assets is depreciated using the straight-line method from the commencement date over the period of lease term.

The Company measures the lease liability at the present value of the lease payments that are not paid at the commencement date of the lease. The lease payments are discounted using the incremental borrowing rate of the company.

For short-term and low value leases, the Company recognises the lease payments as an operating expense on a straight-line basis over the lease term.

O Segment Reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision maker. Management of the Company is responsible for allocating resources and assessing the performance of the operating segment. Revenue, expenses assets and liabilities which are common to the company are shown as results, assets and liabilities as unallocable.

P Statement of Cash Flows

Statement of cash flows is prepared in accordance with the indirect method prescribed in Ind AS-7 'Statement of cash flows.

Q Non-current assets held for sale

The Company classifies non-current assets as held for sale if their carrying amounts will be recovered principally through a sale rather than through continuing use. Actions required to complete the sale should indicate that it is unlikely that significant changes to the sale will be made or that the decision to sell will be withdrawn. Management must be committed to the sale expected within one year from the date of classification.

The criteria for held for sale classification is regarded met only when the assets is available for immediate sale in its present condition, subject only to terms that are usual and customary for sales of such assets, its sale is highly probable; and it will genuinely be sold, not abandoned. The Company treats sale of the asset to be highly probable when:

The appropriate level of management is committed to a plan to sell the asset,

- An active programme to locate a buyer and complete the plan has been initiated (if applicable),
- The asset is being actively marketed for sale at a price that is reasonable in relation to its current fair value,
- The sale is expected to qualify for recognition as a completed sale within one year from the date of classification , and
- Actions required to complete the plan indicate that it is unlikely that significant changes to the plan will be made or that the plan will be withdrawn.

Non-current assets held for sale are measured at the lower of their carrying amount and the fair value less costs to sell. Assets and liabilities classified as held for sale are presented separately in the balance sheet.

Property, plant and equipment and intangible assets once classified as held for sale/ distribution to owners are not depreciated or amortised.

Group Overview, Basis of Preparation and Significant Accounting Policies

1.1 Group Overview

AKG Exim Limited (“the Company” or “the Parent”) is a company incorporated in India. The Company and its subsidiary are collectively referred to as “the Group”.

These consolidated financial statements for the year ended March 31, 2026 were approved by the Board of Directors of the Company at its meeting held on May 27, 2026.

1.2 Statement of Compliance

These consolidated financial statements have been prepared in accordance with the Indian Accounting Standards (“Ind AS”) notified under Section 133 of the Companies Act, 2013 (“the Act”), read with the Companies (Indian Accounting Standards) Rules, 2015, as amended from time to time, and other relevant provisions of the Act. They are presented in the format prescribed under Schedule III to the Act, as applicable to Ind AS compliant companies.

As the Company is listed, the consolidated financial results and related disclosures are also prepared and submitted in accordance with applicable requirements of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.

1.3 Basis of Preparation

These consolidated financial statements have been prepared on the historical cost basis, except for those financial assets and financial liabilities that are measured at fair value or amortised cost, as required under the relevant Ind AS.

The consolidated financial statements are presented in Indian Rupees (“₹”), which is the functional currency of the Company. All amounts are stated in ₹ lakhs, unless otherwise stated, and have been rounded off in accordance with the requirements of Schedule III to the Act.

The accounting policies have been applied consistently by all entities within the Group, except where a different treatment is required under the applicable Ind AS.

1.4 Basis of Consolidation

The consolidated financial statements comprise the financial statements of the Company and its subsidiary as at March 31, 2026.

A subsidiary is an entity controlled by the Group. The Group controls an entity when it has power over the entity, exposure or rights to variable returns from its involvement with the entity, and the ability to use its power to affect those returns.

The financial statements of the subsidiary are consolidated from the date on which control is obtained and continue to be consolidated until the date that such control ceases.

The financial statements of the Parent and its subsidiary are combined on a line-by-line basis by adding together like items of assets, liabilities, equity, income, expenses and cash flows. Intra-group balances, transactions, income, expenses and unrealised gains or losses arising from intra-group transactions are eliminated in full on consolidation.

Deferred tax consequences of temporary differences arising from the elimination of unrealised profits and losses on intra-group transactions are recognised in accordance with Ind AS 12, *Income Taxes*.

Non-controlling interests, if any, are presented separately within equity in the consolidated balance sheet and separately in the consolidated statement of profit and loss and consolidated statement of changes in equity.

1.5 Business Combinations

Business combinations are accounted for using the acquisition method in accordance with Ind AS 103, *Business Combinations*.

The consideration transferred is measured at fair value at the acquisition date. Identifiable assets acquired and liabilities assumed are recognised separately from goodwill at their acquisition-date fair values, except where Ind AS requires another basis of measurement.

Acquisition-related costs are recognised in the statement of profit and loss as incurred, except costs associated with the issue of debt or equity securities.

1.6 Goodwill

Goodwill represents the excess of the consideration transferred, together with the amount of any non-controlling interest and the fair value of any previously held equity interest, over the net identifiable assets acquired and liabilities assumed in a business combination.

Goodwill is not amortised. It is allocated to cash-generating units or groups of cash-generating units expected to benefit from the business combination and is tested for impairment annually, or more frequently when indicators of impairment exist. Any impairment loss recognised on goodwill is not subsequently reversed.

Where the net identifiable assets acquired exceed the consideration transferred, the resulting gain is recognised in the consolidated statement of profit and loss after reassessing the measurement of the identifiable assets acquired and liabilities assumed.

1.7 Foreign Currency Translation

The financial statements of the foreign subsidiary are translated into Indian Rupees for consolidation as follows:

- Assets and liabilities are translated at the closing exchange rate at the reporting date.
- Income and expenses are translated at exchange rates prevailing on the dates of the transactions; average exchange rates for the year may be used where they reasonably approximate actual rates.
- Share capital and other equity components are translated at historical exchange rates.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the foreign currency translation reserve within other equity. On disposal of a foreign operation, the cumulative amount relating to that foreign operation is reclassified to the consolidated statement of profit and loss when required by Ind AS.

1.8 Use of Estimates and Judgements

The preparation of consolidated financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of assets, liabilities, income, expenses and disclosures of contingent liabilities. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised prospectively in the period in which the estimates are revised and in any future periods affected.

1.9 Significant Accounting Policies

Except for the consolidation-specific policies stated above, the significant accounting policies adopted in these consolidated financial statements are consistent with those applied in the standalone financial statements of the Company, to the extent applicable to the Group.
