## CHAIRMAN'S MESSAGE

### Dear Stakeholders



The fiscal year 2023-24 has been a challenging period for the entire textile industry of India. The winds of change have not been in our favor, as we navigated through turbulent waters buffeted by various storms that tested our resilience. Yet our buoyancy towards our work commitments has helped us sustain through hard times.

The foundation of our struggles lies in the unrelenting increased cotton rates in India in contrast with the International cotton rates. This essential raw material forms the lifeblood of our operations and the steep rise in costs has eroded our profit margins. This rise of about 15% in cotton, cotton yarn & cotton products discourages us from engaging in exports as the international market is dynamic, opposing and competitive with manifold international players having higher grade products at modest rates in turn adding another layer of complexity, making it difficult for us to compete effectively in the global market.

Moreover, the market slump faced by the hosiery and textile industry is also a point of discussion. We have battled bravely against a market slump that dampened demand in the fiscal year and left our warehouses filled with unsold inventory. Your company stayed relevant and competitive during the times of market slump at the cost of abated profit margins. Further the taxation system in India, while designed to bring in revenue for the nation, has inadvertently led to a reduction in the purchasing power of retailers and the general public. This has translated into decreased sales for our products, further exacerbating our financial woes.

It is crucial to acknowledge the influence of economic affairs on our industry. While on one hand the global economic landscape and geopolitical changes significantly affect our operations; on the other hand the past economic Indian affairs ranging from demonetization, GST effect to pandemic waves had been serving us with endless setbacks in our path to growth and the after effects of the same is still shaking the hosiery & textile industry in every possible way. From supply chain disruptions to frequent fluctuating raw material costs, we have faced challenges that demanded agility and resilience. Even many of our main board listed peers had also struggled with such troubles and few are still in this uphill battle.

It is disheartening to note that the MSME sector, which forms the backbone of our economy, has not received the priority and support it deserves. Our pleas for assistance and relief have fallen on deaf ears, leaving us to battle these challenges alone. Yet being an MSME and a regional brand, we try our best to keep up with the national and international players in the Hosiery segment. It would not be incorrect to mention that Jet Knitwears Limited is the only MSME registered on NSE from textile industry with no other listed MSME as its peer yet we survive against the main board giant peers and all odds on the basis of huge retailer network.



Given our limited regional reach and advertising budget constraints, as compared to the other global brands and big players in the market, to be able to survive and sustain in this highly volatile and uncertain business arena is no small achievement. If you compare our level of operations with our peers who are listed on the Main Board of the stock exchange, you'll find that there is no plain level field for us, and thus they enjoy an advantageous position in several ways which are instead barriers for us.

But in the face of adversity, we must find the strength to persevere. We are a company built on a legacy of hard work, determination, and innovation. It is during times like these that we must draw upon our core values and rally together as a team. I urge all our employees to stay committed and focused on our goals. Let us redouble our efforts, find new avenues for growth, and explore innovative solutions to overcome the obstacles that stand in our way. Together, we can weather this storm and emerge stronger and more resilient than ever before.

On behalf of the Board, I would like to extend my sincere thanks to the management team, employees, dealers, retailers, suppliers and all other stakeholders for their commitment in the performance during the year. I wish the Jet Knitwears Limited team, the very best to continue to operate with more zeal and confidence.

I strongly believe that the worst is behind us and we look forward towards a better future. I assure you that we, at Jet Knitwears Ltd., would try our level best to leave no stone unturned to create value for all our stakeholders by reaching newer heights and achieving milestones.

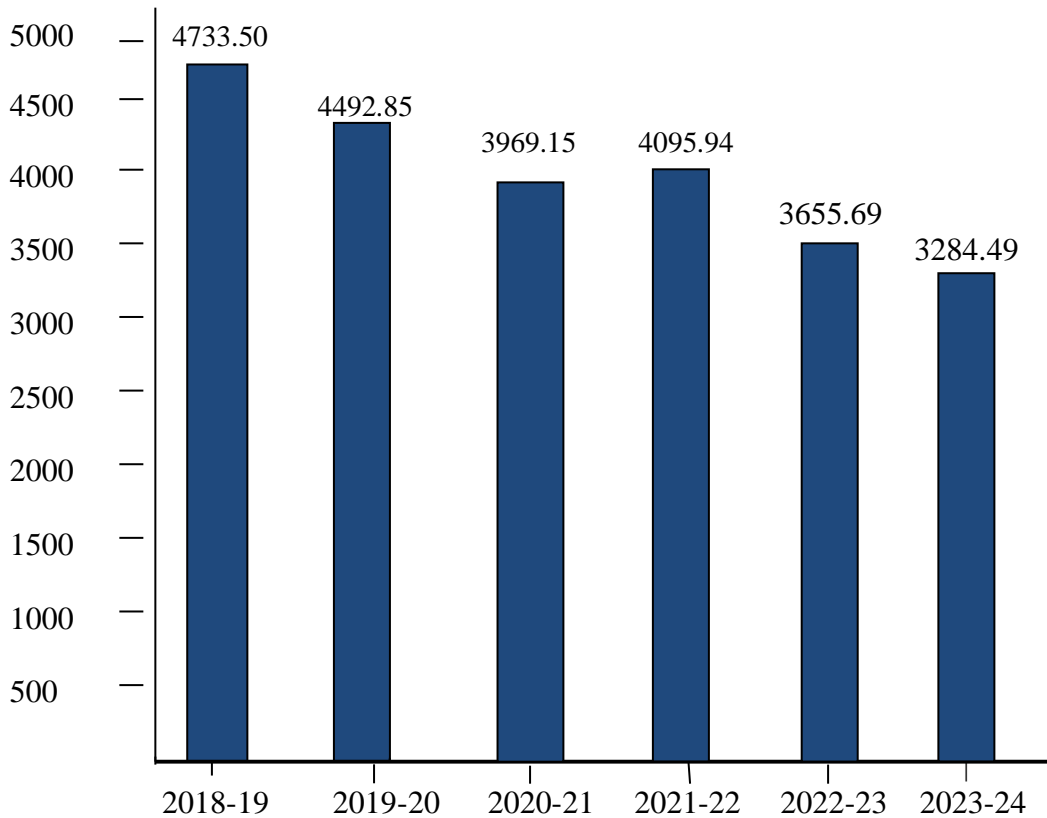

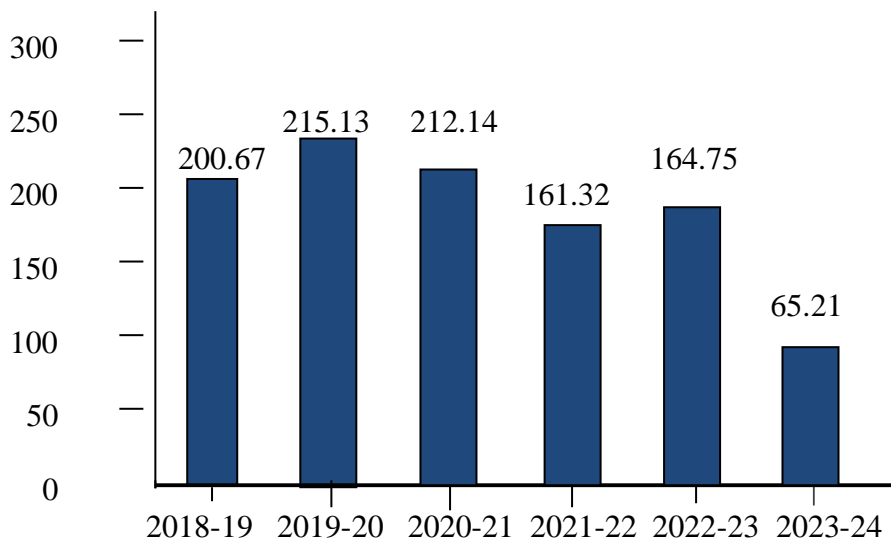
### GROSS INCOME

### PROFIT BEFORE TAX

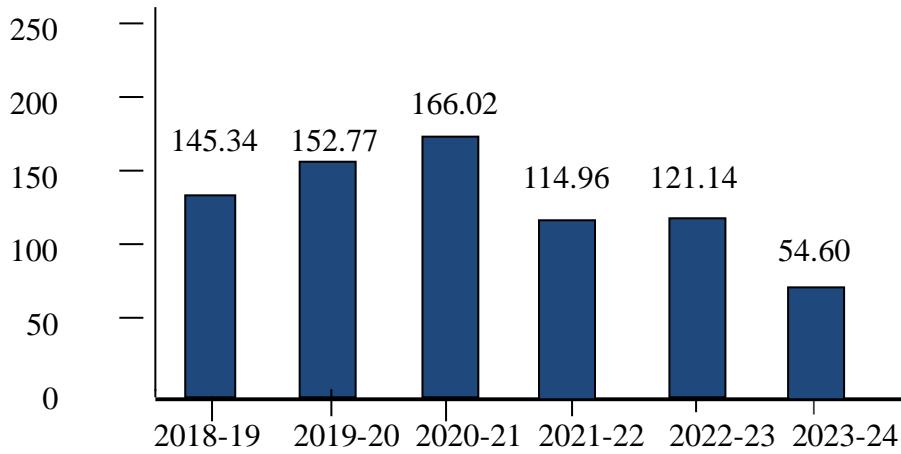

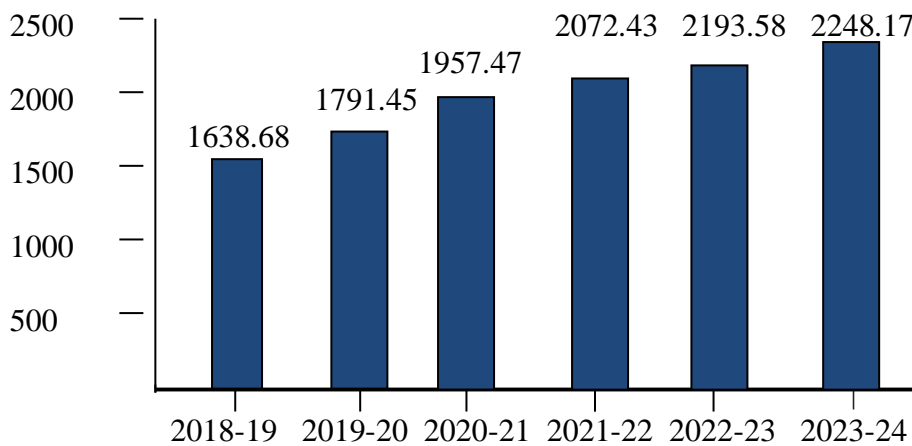
### PROFIT AFTER TAX

(₹ In Lakhs)

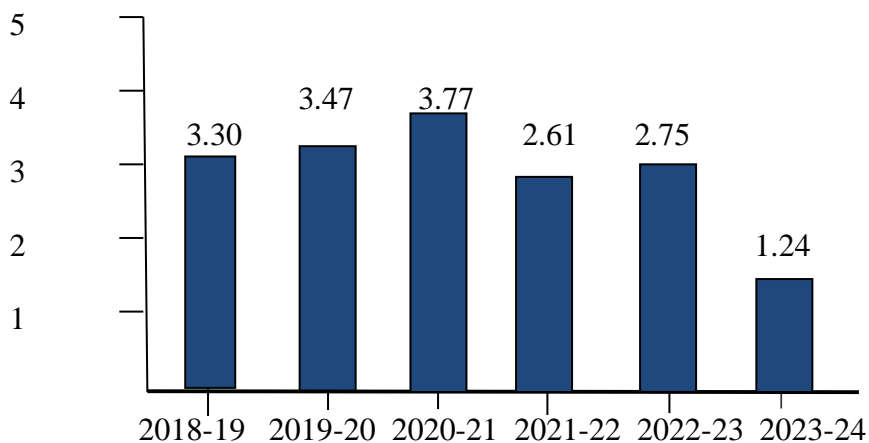


### NET WORTH

Your Directors hereby present the 28<sup>th</sup> Annual Report on the business and operations of Jet Knitwears Limited (the Company or 'JKL') along with the Audited Financial Statements for the Financial Year ended March 31, 2024.

**1. FINANCIAL SUMMARY**

The Company's standalone financial performance for the year ended 31<sup>st</sup> March, 2024 is summarized as below:

**2. STATE OF COMPANY AFFAIRS**

Your Directors report that due to high volatility in market, steep increase in raw material prices and several other challenges, your Company faced some decline in sales and revenue as well as in net profits during the year under review. The major highlights pertaining to the business and operations of the Company for the year 2023-24 are given below:

- The Revenue from operations stood at **₹3275.10** Lakhs as against ₹3650.35 Lakhs in the previous year showing a *decline of about 10.28%*.
- The Profit before tax is **₹65.21** Lakhs as compared to ₹164.75 Lakhs in the previous year thereby showing the *decline of about 60.42%*.
- The EBITDA decreased to **₹234.41** Lakhs from ₹328.10 Lakhs in the previous year and thus showing a decline of about 28.56%.
- The Profit after tax for the year stood at **₹54.60** Lakhs as compared to ₹121.14 Lakhs for the previous year thereby showing a decline of about 54.93%.
- The Earning per Share has also decline to **₹1.24** as against ₹2.75 in the Previous Year.



### **3. OBSTACLES FACED DURING THE YEAR**

Due to rising inflation in the country, the purchasing power of the consumers has been reduced significantly leading to stagnancy in demand in the market, especially for regional brands like us. Additionally, rise in the overall raw material consumption cost also impacted the industry and the Company could not increase the required selling price of the products as compared to increase in the cost of raw materials. Further, many international players are entering Indian market with fast fashion clothing and heavy advertising leading to decline in the overall market place for small and regional brands like us.

### **4. GROWTH STRATEGY**

Your Company has taken measures for the growth and expansion of the business. We have expanded our clothing range and now we are not limited to just hosiery products and undergarments but we have also ventured into the market of new products such as sweat shirts, jackets denims & hoodies etc. which is a complete different segment in itself. This has resulted into the expansion of our product horizon, opening various doors of opportunities for the Company and thereby exposing our reach to wider market coverage. In addition to this, your company has tried to maintain balance of sales between the e-commerce and retail business.

### **5. SUBSIDIARY / ASSOCIATE COMPANY / JOINT VENTURE**

Company does not have any Subsidiary / Associate Company. There were no Joint Ventures entered into by the Company during the financial year 2023-24.

### **6. DIVIDEND**

Keeping in view the current economic uncertainties, your directors consider it prudent to plough back the profits and not to recommend any dividend for the financial year 2023-24.

### **7. RESERVES**

The Company has not transferred any amount to its reserves, the details in respect of which can be verified from the audited financial statement forming part of this report.

### **8. SHARE CAPITAL**

During the year under review, there was no change in either Authorised or Paid-Up Share Capital of your Company.

### **9. COMPOSITION OF BOARD**

The Board of Directors of the Company has an optimum composition of Executive, Non-Executive and Independent Directors in compliance with the provisions of Companies Act, 2013 and SEBI (LODR) Regulations, 2015. As on March 31, 2024, Board of Directors comprise of 7 Directors out of which 2 are Executive Directors, 1 is Non-executive Director, 1 is Non Executive Non-Independent Woman Director and 3 are Non Executive Independent Directors which is in compliance with the provisions of Companies Act, 2013. All Independent Directors are eminent persons and bring a wide range of expertise and experience to the Board thereby ensuring the best interest of stakeholders and the Company. As per provisions of the Companies Act, 2013, Mr. Ramesh Chandra & Mr. Ashok Chandra Bajpai, Independent Directors were re-appointed in the 24<sup>th</sup> AGM of the Company held on September 30, 2020 for a second term of 5 (Five) consecutive years commencing from August 01, 2020 to July 31, 2025 and are not liable to retire by rotation. Further, Mrs. Avantika Mishra was appointed Independent Director of the company in 27<sup>th</sup> AGM held on September 29, 2023 for a first term of 5 consecutive years commencing from August 29, 2023 to August 28, 2028.

During the financial year under review, the tenure of Mr. Balram Kumar Narula as Managing Director of the Company expired on May 14, 2023 and on EGM held on May 29, 2023, he was re-designated as Chairman (Non-Executive) of the company.

## 10. DECLARATION BY INDEPENDENT DIRECTORS

The Company has received necessary declarations from Mr. Ramesh Chandra, Mr. Ashok Chandra Bajpai & Mrs. Avantika Mishra, Independent Directors of the Company confirming that they meet the criteria of independence as prescribed under Section 149(6) of the Companies Act, 2013 ("Act") and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"). In the opinion of the Board, they fulfill the conditions of independence as specified in the Act and the Listing Regulations and are independent of the Management.

seeking re-appointment is given in the Statement under Section 102 of the Companies Act, 2013 to the Notice of the ensuing AGM of the Company.

## **14. EVALUATION OF BOARD'S PERFORMANCE**

Your Company being listed on SME Exchange – “NSE Emerge” is exempt under Regulation 17(10) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. However, pursuant to the provisions of section 134(3)(p) of Companies Act, 2013, the Board has carried out annual evaluation of the performance of the Board, its Committees and of individual directors based on devised criteria. Furthermore, in a separate meeting of Independent Directors held on March 11, 2024; performance of the Non-Independent Directors and the Board as a whole was also reviewed.

The Company has devised a policy naming (Policy on Nomination & Remuneration and Board Diversity) for performance evaluation of Independent Directors, Board, Committees and other individual directors which includes the criteria and process for the performance evaluation of the Executive/ Non executive Directors, Committees and the board as a whole. ## 26. AUDITORS AND THEIR REPORT

### Statutory Auditor

In terms of the provisions of Section 139 of the Companies Act, 2013, read with provisions of the Companies (Audit and Auditors) Rules, 2014 as amended from time to time, M/s Rajiv Mehrotra & Associates, Chartered Accountants, (FRN: 002253C) Kanpur, were re-appointed as the Statutory Auditors of the Company for a second term of 5 consecutive years in the 26<sup>th</sup> Annual General Meeting held on September 27, 2022 till the conclusion of the 31st Annual General Meeting.

Based on the recommendation of the Audit Committee, your Board at its meeting held on August 24, 2022 reappointed M/s Rajiv Mehrotra & Associates, Chartered Accountants, (FRN: 002253C) Kanpur, as the Auditors of the Company to hold the office from the conclusion of the ensuing 26<sup>th</sup> AGM until conclusion of the 31<sup>st</sup> AGM of your Company to be held in the year 2027, subject to approval of members of the Company at the 26<sup>th</sup> Annual General Meeting.

They have also confirmed that they hold a valid certificate issued by the Peer Review Board of the Institute of Chartered Accountants of India as required under the provisions of Regulation 33 of the Listing Regulations.

### Audit Report

The notes on financial statement referred to in the Auditor's Report are self-explanatory. No frauds are reported by the Auditors which fall under the purview of sub section (12) of Section 143 of the Companies Act 2013. Further, Disclaimer of Opinion is made by the Auditor in its Audit Report. Details of which are as follows:

**Basis for Disclaimer opinion in the Statutory Audit Report:** The Company's trade receivables (classified as unsecured and considered good by the management & Net of Provisions) are carried at Rs. 1567.69 lakhs, out of which Rs. 911.25 lakhs are outstanding for a period more than six months, which is abnormally high as compared to the turnover of the company. Also out of the above, receivables of Rs. 128.81 lakhs are aged more than three years. The balances of these parties are subject to confirmation, and as per the management of the company are recoverable.

We draw attention to Note No. 1(D)(vii) of the Financial Statements, which describes a petition filed by a shareholder under Sections 241, 242, and 244 of the Companies Act, 2013, alleging oppression and mismanagement by the current Board of Directors. This petition is currently pending before the National Company Law Tribunal, Allahabad Bench. The outcome of this matter is uncertain, and as stated in the said note, the management does not anticipate any impact on the Company at this time.

The company's records relating to the WIP stock are not commensurate with the magnitude of data involved, as more than 30 job workers and 4 different stages are engaged in the process. According to management, a system for data maintenance is currently under development.

Additionally, we have not verified the physical inventory and have relied upon the physical verification reports provided by the management in this behalf. The value of the total inventory is abnormally high compared to the turnover, and there is no proper record of the ageing of the inventory. As a result, non-moving or obsolete inventory could not be ascertained.

The company has used accounting software for maintaining its books of account which does not have a feature of recording audit trail (edit log) facility enabled throughout the year.

**Key Audit Matters (KAM): Substantial Movement of Stock up to production of Finished Goods**





The company avails services of over thirty job workers and has inter dependent manufacturing facilities in two States in India. In addition, the company has several depots. The above entails substantial movement of raw material, semi-finished materials and finished goods from one location to another; and at any given point of time, the stocks (of various stages) belonging to the company may be found at several locations. The movement of stock is the key to the business and was therefore considered as one of the 'Key Audit Matters'. Verification of the internal controls with respect to inventory management and movement, recording of consumption, valuation of stocks as at the reporting date involved extensive verification procedures and called for making estimates and judgments.

#### Response to Audit Observations

The Board of Directors of the company furnish following response to the Disclaimer of Opinion made by the Auditor in their Report dated May 29, 2024 for the Standalone Financial Statements for the year ended March 31, 2024:

Based on the Management analysis and assumptions, we believe that the Profit and Loss Account and Cash Flow Statement for the year ended March 31, 2024 and the Balance Sheet as at March 31, 2024 are materially correct and as per the management, the trade receivables are considered good and are recoverable in nature. The company's trade receivables consist of outstanding balances from over 3000 parties, spread across various remote locations within the operational area of the Company and are generally low in value individually, since the supply chain of the company largely consists of small retailers, who were severely impacted by the post pandemic effects and now by slow market pace. The Management is making full efforts to recover these trade receivables. Hence, management does not believe there is any material financial impact of the audit qualification.

With reference to the NCLT petition pending against the company, management believes that there is no material impact of the same on the financial position of the company.

Further, the Company manufactures various products like Vest, Underwear (including Boxers, Briefs & Trunks), Brassiere, Panties, Socks, T-shirts, Thermals, Lowers, Jeans etc. for men, women & children in different sizes for all age groups and markets it through various brands like Lycot Australia", "Jet", "Jet Eco", "Fresh- Long", "Boski" and "Take- off". This huge product line under various brand names is to cater the customers' needs which usually vary from affordable to luxury range which helps company to stay relevant & competitive in ever changing business environment. Due to above facts, company's inventory stays high at most of the times.

As regard to maintaining books of accounts using accounting software which should have feature of recording audit trail (edit log) facility enabled throughout the year, the company have offices, depots & godowns at various locations & different accounting software were in use at different places. Due to this, company faced issue while updating such software to enable the audit trail feature which caused some unavoidable delay to comply with the said requirement. However the accounting software with enabled audit trail feature was in place most of the time at all locations during the financial year under review.

In respect of Key Audit Matters, the management submits that the internal control systems for data maintenance with respect to inventory management, movement and valuation of stocks as at the reporting date are currently under development. It is pertinent to note that, we have various ranges of products for men, women and children which are manufactured in different sizes for all age groups. And each different product requires different setup and goes through multiple processes and stages. Thus the average production cycle, right from procurement of yarn till the completion of the finished product ready for sale, takes around 50 days; making the internal systems required for tracking the movement and valuation of stock at different stages a tedious and complex task for the management. Nevertheless, we are making full efforts to extend the internal controls throughout all the production stages so that proper information is



readily available at all times regarding the movement and valuation of the inventory at several locations and less reliance is to be placed on estimates and judgements.

### Internal Auditor

M/s Rajesh Singhania & Associates, Chartered Accountants, has been appointed as the Internal Auditors to perform the Internal Audit of the Company for the Financial Year 2023-24. The Audit Committee of the Board in consultation with the Internal Auditor formulates the scope, functioning, periodicity and methodology for conducting the internal audit.

### Secretarial Auditor

The Board had appointed CS Gopesh Sahu, Practicing Company Secretary (Membership No. 7100, C.P. No. 7800) to undertake the Secretarial Audit of the Company for the Financial Year ended March 31, 2024.

The Secretarial Audit Report for the Financial Year ended March 31, 2024 annexed herewith is marked as **Annexure II** to this Report. The Secretarial Audit Report does not contain any qualification; however, following observation has been made by the Secretarial Auditor in his report:

*“The Company Petition filled by Mr. Manoj Agarwal & M/s Haryana Refractories Private Limited Persons acting in Concert & shareholders of the Company is pending before the Hon’ble NCLT, Allahabad Bench, Prayagraj, since the matter is sub-judice hence, I choose not to comment upon the same.”*

### Response to Secretarial Audit Observation

Management’s Reply to Observation- This observation is self-explanatory.

### Cost Audit

The provisions of Section 148 of the Companies Act 2013 read with the Companies (Cost and Audit) Rules, 2014 and Rule 14 of the Companies (Audit and Auditor) Rules, 2014 are not applicable to the Company.

## MANAGEMENT DISCUSSION AND ANALYSIS REPORT

### ECONOMIC OUTLOOK

#### GLOBAL:

In the financial year 2023-24, the global economy was expected to witness modest economic growth rates of around 3-3.5% with variations across regions. However, the baseline forecast is for growth to fall from 3.4 percent in 2022 to 2.8 percent in 2023, before settling at 3.0 percent in 2024. Advanced economies are expected to slow from 2.6 percent in 2022 to 1.5 percent in 2023 and 1.4 percent in 2024 as policy tightening starts to bite. Emerging market and developing economies are projected to have a modest decline in growth from 4.1 percent in 2022 to 4.0 percent in both 2023 and 2024. Global inflation is forecast to decline steadily, from 8.7 percent in 2022 to 6.9 percent in 2023 and 5.8 percent in 2024, due to tighter monetary policy aided by lower international commodity prices. Core inflation is generally projected to decline more gradually, and inflation is not expected to return to target until 2025 in most cases. While emerging markets show potential for higher growth, developed economies face challenges such as inflationary pressures and policy uncertainties.

Divergent growth prospects across the world's regions pose a challenge to returning to pre-pandemic output trends. Despite signs of resilience earlier in 2023, the impact of policy tightening to reduce inflation is expected to cool economic activity going forward. Further, Russia Ukraine War caused major commodity markets to fragment and geopolitical tensions made things worse.

Sustainability and ESG principles play a crucial role, influencing consumer preferences and investor decisions. Supply chain resilience and flexibility are key priorities, given ongoing disruptions from the pandemic and geopolitical factors. Remote work trends persist, shaping business strategies and operational models. Despite risks like pandemic uncertainties, interest rate hikes, and trade policy changes, opportunities exist in the green economy, digital transformation, e-commerce, and health-tech sectors. Adapting to these trends and seizing growth opportunities were essential for businesses to thrive in the dynamic global economic landscape of 2023-24.

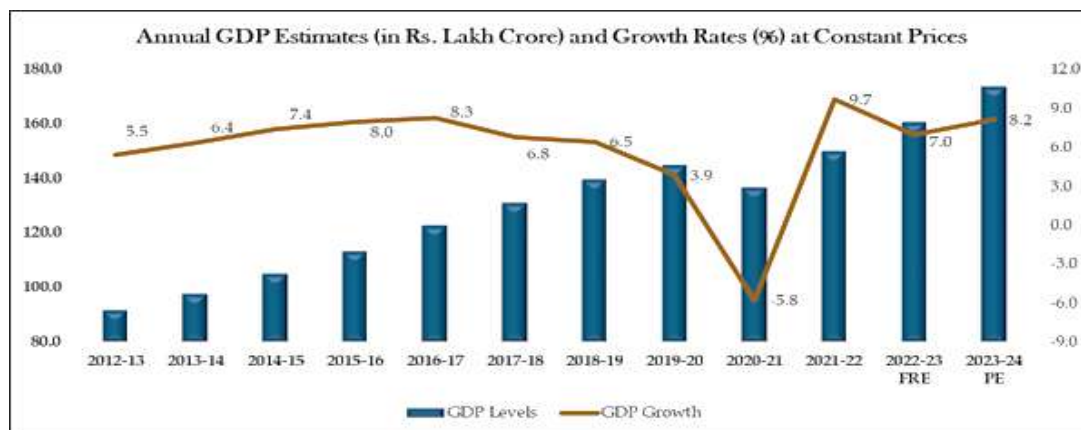
## **INDIAN:**

India has emerged as the fastest growing major economy in the world and is expected to be one of the top three economic powers in the world over the next 10-15 years, backed by its robust democracy and strong partnerships. Strong economic growth in the first quarter of FY23 helped India overcome the UK to become the fifth-largest economy and showed a strong recovery from the COVID-19 pandemic shock.

2023 marked a landmark year for India as it assumed presidency of the world's highest profile global economic assembly, the G20, and showcased its economic prowess and diplomatic finesse to the world.

### ***Current State of the Economy-***

- Indian economy remained resilient with robust 7.6% growth rate of GDP in FY 2023- 24 over and above 7% growth rate in FY 2022-23. India has been a key growth engine for the world, contributing 16% to the global growth in 2023. (Source: PIB India & World Economic Forum).
- The International Monetary Fund (IMF) has raised India's growth forecast for 2024- 25 to 6.8% from 6.5% on the back of strong domestic demand and a rising working age population. According to the PHD Chamber of Commerce and Industry (PHDCCI), India's economy is poised to grow between 8 to 8.3% in the current fiscal year emphasizing the country's robust growth fundamentals, projecting an average GDP growth rate of 6.7% over the next 23 years.
- Double-digit growth rate of Construction sector (10.7%), followed by a good growth rate of Manufacturing sector (8.5%) have boosted the GDP growth in FY 2023-24. Private consumption in the first half of FY 2023-24 was the highest since FY15 and this led to a boost to production activity resulting in enhanced capacity utilisation across sectors.
- The central government's fiscal deficit shrank from 6.4% of GDP in FY2022 to an estimated 5.8% in FY2023. Revenue performance exceeded expectations and pushed the deficit lower than the budget target of 5.9% of GDP in FY2023.
- Personal income tax collections are estimated to have grown by 23.0% in FY2023, highlighting surging incomes for salaried professional. This was also a sign of successful government effort to widen the tax base by keeping tax exemption limits stable and using digital tools to prevent tax leakage. (Source: PIB India)
- Strong domestic demand for consumption and investment, along with Government's continued emphasis on capital expenditure are seen as among the key driver of the GDP in the first half of FY2023-24.





## **INDUSTRY STRUCTURE AND DEVELOPMENT**

### **Textiles & Apparels**

The Indian Textile industry witnessed major challenges in 2023 due to fluctuating cotton prices, diminishing demand, capacity under-utilization and dumping of imported fabrics and garments from China and Bangladesh. The buying by the US and EU has remained quite low and that too for an unusually longer period, which has affected the exports badly. The year gone by has been one of the most challenging years for the Indian textile industry.

Despite gradual destocking by the buying houses, the exporters could not get sufficient orders in 2023 due to policy of keeping very low inventories by the retailers as a result of lack of demand in the two most important consumer markets, namely the US and EU. In October 2023, the US apparel imports were USD 6.5 bn., which was 21% lower than October 2022. In November 2023, India's apparel exports are estimated to be USD 1.0 bn., which was 17% lower than in November 2022.

A paradigm shift is happening globally. The global garment industry is shrinking both on consumer, retailer as well as supplier side. Experts expect the US garment imports to continue declining 25% to 30%. This means the market will not recover in the foreseeable future for the exporters. The US retail sector is undergoing a big transformation. The US garment imports fell by 22.8% in value terms in September 2023; hence retailers preferred to reduce garment imports and worked on minimal stocking. This trend is expected likely to continue for at least next two more quarters till market equilibrium is reached.

Bangladesh resorted to imports of cheap raw materials from China and exporting the finished products to the EU and US. Having the tag of least developed country, none of its products come under any import tax. As a result of the above, Indian exports remained stagnated around \$16.5 billion, while Bangladesh has already crossed the \$44 billion mark. This situation is because of India not getting a level playing field in these top two markets.

The total imports of knitted fabric in FY 2022-23 were Rs 6073 crores and in the first five months of current FY 2023-24 imports have already crossed more than Rs 2594 crores. The main source of India's imports of knitted or crocheted fabric is China, which accounted for majority of the total value, followed by Vietnam, Taiwan, Malaysia and Bangladesh. Polyester-based knitted fabrics hold the major share of imports, which is more than 60% of the total knitted fabrics imports. These fabrics are used for T-shirts, track suits, sportswear and active wears, which are some of the fastest growing segments of Indian textile and apparel industry. Even 100% cotton fabric import is more than Rs 400 crores, pile fabric import is more than Rs 600 crores and the warp knit fabrics import is more than Rs 750 crores.

India has a huge requirement of knitted fabrics for domestic consumption as also for apparel exporters. However, due to poor finishing set up, enough quantity of good quality fabrics is always in shortage locally, which results in massive imports. This needs to be controlled with more capacities created with state-of-the-art technology, especially in finishing.

The Free Trade Agreement (FTA) signed between India and Bangladesh is derailing India's textile exports as well as its share in the home market. Fabrics imported from Bangladesh are exempted from customs duty due to which the imports from Bangladesh are increasing every month, which is upsetting the Tirupur manufacturers. In 2022-23, the imports of knitted fabrics from Bangladesh increased to Rs 264 crore from Rs 212 crore in the previous year. This increase of 24% has put local manufacturers in trouble. In 2022-23, the imports of knitwear garments increased by a whopping 57% to Rs 2489 crore from Rs 1576 crore in the previous year. This has clearly landed the local knit goods manufacturers in big trouble.





All the above factors have been responsible for the trouble the Indian textile manufacturers have faced in 2023. Some intervention from the government is absolutely must to save the local industry.

The Indian domestic market is sluggish too. Even the festival season did not bring cheers to the manufacturers, unlike earlier years. It seems that the people are giving preference for food items, buying consumer equipment, gadgets like mobiles, i-pads, etc. as also cars and bikes over garments. The spinning sector reeled under high under-utilization due to reduced yarn imports by China as well as reduced buying by weavers and knitters. Reduced exports and dull local consumption resulted in trouble for the local textile industry. The PLI and PM Mitra schemes are expected to attract investments in man-made fibre and technical textile products and reduce the import dependability over the years. The athleisure and sportswear segment has however shown tremendous growth with the brands doubling their sales in the last two years. However, in this segment too most of the man-made fibre spandex fabrics have been imported from China, Vietnam and Taiwan. The margins of the textile mills are under pressure, although the cotton prices have stabilized by now around 2-year low.

The Indian textile industry is now grappling with a significant setback as freight costs witness a staggering 40% increase due to unrest in the Red Sea. This unexpected spike in transportation cost has raised concerns about its impact on operational costs and pricing.

The biggest change in the consumer markets globally have been the fall in demand due to various factors, including recessionary trends, increased food prices, increased energy prices in some countries because of the two wars that are presently on. According to the industry experts, the two major global markets, the US and the EU, are likely to continue with their reduced garment imports for at least another two quarters. In fact, the statistics show that all the other major markets such as UK, Japan and UAE have also reduced their imports in 2023 due to reduced consumption. This trend is likely to continue for some more time.

There is going to be growth in technical textile and man-made fibre industry in the new year due to government benefits. This should help India in regaining some global market share. There will be more push towards attaining sustainability and traceability in manufacturing processes as well as in products. More interest is likely in investments in the recycling technologies as well as technologies that will help in saving water and chemicals. At last for 2024, the textile producers need to look at making niche products, product basket diversification and exploring new markets like Japan.

### **Innerwear Market Segment**

The innerwear market in India, which has witnessed substantial growth over the past decade, has exhibited notable resilience during times of adversity. Emerging from a valuation of Rs 61,091 crores in 2023, the market is on a trajectory to touch INR 75,466 crores by 2025, at a CAGR of 11.2%. This transformation is driven by several factors.

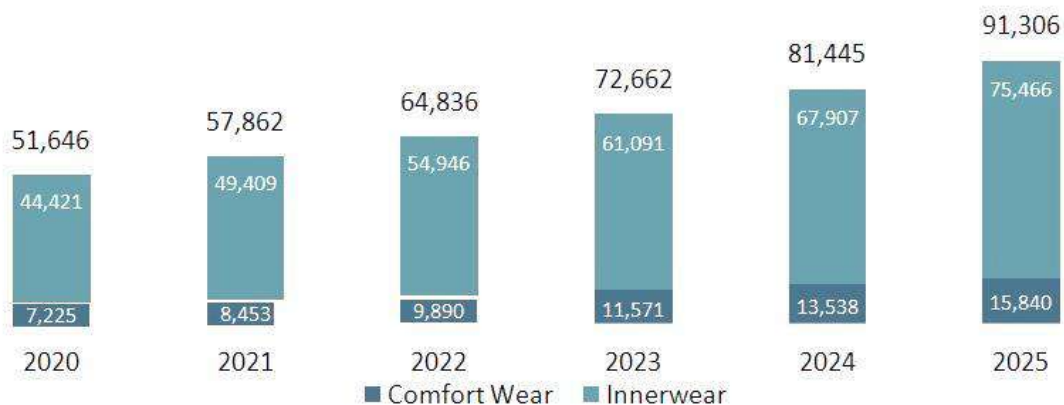
- > Increasing health consciousness among consumers has spurred demand for innerwear made from breathable materials.
- > Rising disposable incomes have led consumers to invest in premium branded innerwear that matches their preferences.
- > Fashion trends showcased on various channels including social media have fueled a preference for innerwear that reflects personal style.
- > Additionally, urbanization is amplifying these trends, particularly in tier 2 and tier 3 cities, highlighting the market's potential.



> Trends such as consumers prioritizing both aesthetics and comfort, catalysed by the pandemic, have also spurred growth in the comfort wear segment, which was estimated at Rs 11,571 crores in 2023 and is expected to grow at a CAGR of 17% to reach Rs 15,840 crores by 2025.

> Together, the inner & comfort wear market are projected to be valued at Rs 91,306 crores in 2025, growing at a CAGR of 12.1% between 2023-25, with innerwear accounting for over 80% of this market.

**Market Size of Inner & Comfort Wear (INR crores)**

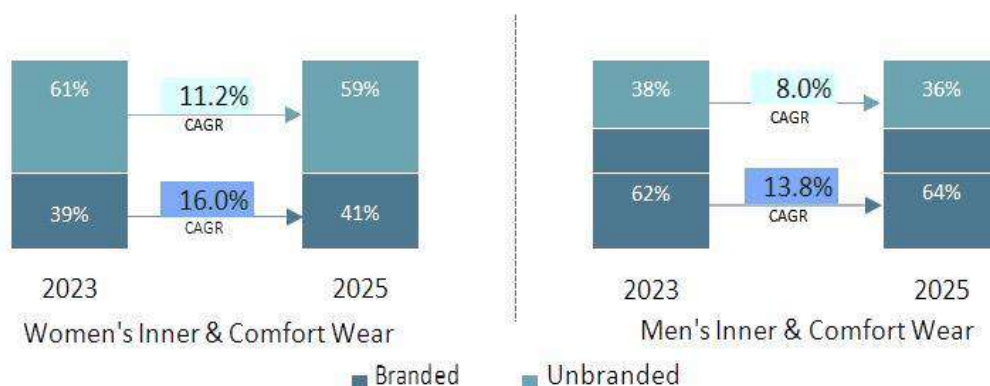


However, even though innerwear market segment is growing; the consumer preference has shifted from affordable products to heavily branded products and this gap between the branded market segment which is acquired by big market players and the unbranded market segment is widening by every passing day.

In the men's inner & comfort wear realm, the ascendancy of branded products has been notable, constituting 62% of the market share in 2023 and projected to strengthen to 64% by 2025. This upward trajectory reflects a distinct consumer preference for established brands only.

The women's inner & comfort wear branded market, which had a 39% share in 2023, is expected to grow at a faster pace than men's branded market to reach 41% share by 2025.

## **OPPORTUNITIES AND THREATS**

### *Opportunities*

- The Indian government has several portals for the welfare of laborers. Udyam, NCS, e-Shram, and ASEEM are the government portals that help people in finding employment in various MSMEs. All these portals are now interlinked to help business owners in finding manpower.
- The Union Finance Minister has emphasized the development of infrastructure and the setting of centralized Effluent treatment plants for the textile industry under IPDS and CETP. So, funds are allotted in the current budget for these purposes, for the best interest of this industry in India.
- Production-linked incentive (PLI) scheme launched for promoting the apparel industry has attracted investment of Rs. 19,000 Crores approximately and generate almost 7.5 Lakhs new employment opportunities.
- With regard to 'Make In India' initiative and to boost employment generation through setting up of 7 (Seven) PM Mega Integrated Textile Region and Apparel (PM MITRA) Parks in Greenfield/Brownfield sites with world class infrastructure
- Increase in fashion and brand consciousness making consumers more aspirational and discerning; increasing urban women population and women corporate workforce has proved to be beneficial for women segment of apparel market.
- Today with technological advancements, we notice a wide array of comfortable fabrics being used. From nylon to organic cotton, spandex blend cotton fabric to modal and from micro-fiber to more durable material. This has led to product innovations in the industry.

### **Threats & challenges**

- The post pandemic effects and multiple global as well as domestic factors have slowed down the commercial activities. The lack of funds to buy raw materials for production was another drawback in this industry. Political tensions or militant activities in some places hinder the smooth operations of the textile industry there. Many textile companies face severe labor shortages and a lack of regular transportation if their factories are located in remote places.
- The inflation in the Indian economy results in frequent demands among laborers for salary hikes. Thus, industry owners do not find the means to expand their business and compete with global textile leaders from other countries.
- The high cost of power in India is another hindrance to textile production. Most modern machines are power-driven, which raises the overall production costs for business owners.
- Fluctuating prices of the raw materials such as cotton, yarn, and chemicals, and thereby raising price of the finished products not be viable in a competitive market.
- Ever changing fashion needs of consumers put industry players in a pressure to constantly adapt emerging fashion trends in the markets.
- Several International apparel brands are entering into India as the country is emerging as one of the largest apparel market in the world and on the other hand new start ups are entering market with aggressive marketing and discounts.

## **PRODUCT –WISE PERFORMANCE**



The company is engaged in the business of manufacturing garments. Therefore there is no separate reportable segment. However, your Company have been marketing products through strong brands “JET” and “LYCOT”. “JET” is 36 years old whereas “LYCOT” is 16 years old. Your Company believes in providing those products to our consumers that are Skin Friendly and Anti-Bacterial. Your Company markets its products through various brands like “Lycot Australia”, “Jet”, “Jet Eco”, “Fresh- Long”, “Boski” and “Take- off”. Various product manufactured by our Company are Vest, Underwear (including Boxers, Briefs & Trunks), Brassiere, Panties, Socks, T-shirts, Thermals, Lowers, etc. Our Company caters to everyday range of comfortable Innerwear, Socks, T-shirts and Thermals which are available in superior cotton fabrics, vibrant styles and are ideally suited for men and women. ## RISK AND CONCERN

The Company has robust risk management procedures to identify and evaluate risks on an ongoing basis. ### ➤ Availability of Labour

The Company has created long term plans with the objective of motivating employees to create a sense of “belonging” and a ‘feel good’ environment. ### ➤ Economic Uncertainty:

Slow economic growth in the international or national economies and uncertainties regarding future economic prospects, among other things, could affect consumer discretionary spending and therefore can impact business. Through brand strengthening and expanding presence across the globe the Company endeavours to mitigate the impact of this risk as far as possible.

### ➤ Increase in Input and Labour costs:

The availability of raw materials at reasonable rates is one of the main concerns of the company. However the company is confident that increases in raw material cost, if and when they occur, can be passed on to consumers because of the strong pricing power of its brands. The company is also aggressively taking steps to monitor and improve productivity, which will mitigate the impact of labour and material cost increases to some extent.

The future of the textile market and the innerwear category is getting competitive domestically as well as globally. Your Company operates from Kanpur with having dealers/vendors in Uttar Pradesh. Enhancing our presence in additional region will enable us to reach out to a larger population. Further, our Company believes in maintain long term relationship with our customers by adding value through innovations, quality assurance and timely delivery of our products which will ultimately enhance our sales.

## INTERNAL CONTROL SYSTEM AND ADEQUACY

Management has overall responsibility for the Company's internal control system to safeguard the assets and to ensure reliability of financial records. The Company has an adequate internal control system commensurate with its size and nature of its business. The Company has a detailed budgetary control system and the actual performance is reviewed periodically and decisions taken accordingly. ## DISCUSSION ON FINANCIAL PERFORMANCE WITH RESPECT TO OPERATIONAL PERFORMANCE

- Our Revenue from operations has decreased from 3650.35 Lacs (F.Y. 2022-23) to ₹3275.10 Lacs during the financial year 2023-24.
- The Depreciation and amortization expense has increased from ₹47.06 Lacs (FY 2022-23) to ₹52.51 Lacs during the financial year 2023-24.
- Our Operating, Administrative and other expenses have been decreased from ₹ 582.73 Lacs (FY 2022-23) to ₹ 567.67 Lacs (FY 2023-24).
- Net profit has decreased from ₹121.14 Lacs (FY 2022-23) to ₹54.60 (FY 2023-24).

## **INDEPENDENT AUDITORS' REPORT**

### **TO THE MEMBERS OF JET KNITWEARS LIMITED REPORT ON THE AUDIT OF THE STANDALONE FINANCIAL STATEMENTS**

#### ***DISCLAIMER OF OPINION***

We were engaged to audit the accompanying standalone financial statements of Jet Knitwears Limited ("the Company"), which comprise the Balance Sheet as at 31 March 2024, the Statement of Profit and Loss, and Statement of Cash Flows for the year then ended, and notes to the standalone financial statements, including a summary of significant accounting policies and other explanatory information (hereinafter referred to as "the standalone financial statements").

We do not express an opinion on the accompanying standalone financial statements of the company. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these standalone financial results.

#### ***BASIS FOR DISCLAIMER OF OPINION***

The company's trade receivables (classified as unsecured and considered good by the management & Net of Provisions) are carried at Rs. 1567.69 lakhs, out of which Rs.911.25 lakhs are outstanding for a period more than six months, which is abnormally high as compared to the turnover of the company. Also out of the above, receivables of Rs. 128.81 lakhs are aged more than three years. The balances of these parties are subject to confirmation, and as per the management of the company are recoverable.

We draw attention to **Note No. 1(D)(vii)** of the Financial Statements, which describes a petition filed by a shareholder under Sections 241, 242, and 244 of the Companies Act, 2013, alleging oppression and mismanagement by the current Board of Directors. This petition is currently pending before the National Company Law Tribunal, Allahabad Bench. The outcome of this matter is uncertain, and as stated in the said note, the management does not anticipate any impact on the Company at this time.

The company's records relating to the WIP stock are not commensurate with the magnitude of data involved, as more than 30 job workers and 4 different stages are engaged in the process. According to management, a system for data maintenance is currently under development.

Additionally, we have not verified the physical inventory and have relied upon the physical verification reports provided by the management in this behalf. The value of the total inventory is abnormally high compared to the turnover, and there is no proper record of the ageing of the inventory. As a result, non-moving or obsolete inventory could not be ascertained.

The company, has used accounting software for maintaining its books of account which does not have a feature of recording audit trail (edit log) facility enabled throughout the year.

As a result of these matters, we were unable to determine whether any adjustments might have been found necessary in respect of recorded amount of Trade Receivables, Inventory, Contingent Liability and the elements making up the statement of Profit and Loss and statement of cash flows.

#### ***EMPHASIS OF MATTER***



We draw the attention towards the followings

Further, the company have been sanctioned a new Skill Development Project under Deen Dayal Upadhyay - Grameen Kaushalya Yojna (DDU GKY Scheme) of Assam State Rural Livelihoods Mission (ASRLM) to train 1000 Candidates in projects (Rural Youth as defined in guidelines of DDU-GKY) with placement linkage by setting up a training/skill center at Majuli and Karimganj for the State of Assam.

We did not audit the financial statements and other financial information, in respect of this scheme. Amounts received and expended under this scheme is subject to audit by a separate auditor, which financial statement and other financial information and auditor's reports have been furnished to us by the management. Our opinion on the financial statements, in so far as it relates to the amounts and disclosures included in respect of this scheme and our report in terms of sub-sections (3) of Section 143 of the Act, in so far as it relates to the aforesaid scheme is based solely on the report of such other auditor.

Our opinion is not qualified in respect of the above.

### **KEY AUDIT MATTERS**

Key audit matters ('KAM') are those matters that, in our professional judgment, were of most significance in our audit of the standalone financial statements of the current period. These matters were addressed in the context of our audit of the standalone financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

We have determined the matters described below to be the key audit matters to be communicated in our report. We have fulfilled the responsibilities described in the Auditor's responsibilities for the audit of the standalone financial statements section of our report, including in relation to these matters. Accordingly, our audit included the performance of procedures designed to respond to our assessment of the risk of material misstatement of the standalone financial statements. The result of our audit procedures, including the procedures performed to address the matters below, provide the basis for our audit opinion on the accompanying standalone financial statements.

### **Substantial Movement of Stock upto production of Finished Goods**

The company avails services of over thirty job workers and has inter dependent manufacturing facilities in two States in India. In addition, the company has several depots. The above entails substantial movement of raw material, semi-finished materials and finished goods from one location to another; and at any given point of time, the stocks (of various stages) belonging to the company may be found at several locations. The movement of stock is the key to the business and was therefore considered as one of the 'Key Audit Matters'. Verification of the internal controls with respect to inventory management and movement, recording of consumption, valuation of stocks as at the reporting date involved extensive verification procedures and called for making estimates and judgments.

### **How our audit addressed the key audit matter**

For the matter referred to above, our procedures included, among others, procedures of physical examination, end to end verification of stock transfers, other relevant documentation/correspondence, including post balance sheet date events, reports submitted to Banks and other authorities, assessing management's conclusions etc. in view of the laid down accounting and measurement principles.

***INFORMATION OTHER THAN THE FINANCIAL STATEMENTS AND AUDITOR'S REPORT THEREON***

The Company's management and Board of Directors are responsible for the other information. The other information comprises the information included in the Company's annual report, but does not include the standalone financial statements and our auditors' report thereon.

The other information included in the annual report, are expected to be made available to us after the date of this auditor's report.

Our opinion on the standalone financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the standalone financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the standalone financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement therein, we are required to communicate the matter to those charged with governance.

***MANAGEMENT'S RESPONSIBILITY FOR THE STANDALONE FINANCIAL STATEMENTS***

The Company's management and Board of Directors are responsible for the matters stated in Section 134(5) of the Act with respect to the preparation of these standalone financial statements that give a true and fair view of the state of affairs, profit and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the Accounting Standards specified under Section 133 of the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the standalone financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the standalone financial statements, management and Board of Directors are responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

The Board of Directors is also responsible for overseeing the Company's financial reporting process.

***AUDITOR'S RESPONSIBILITIES FOR THE AUDIT OF THE STANDALONE FINANCIAL STATEMENTS***

Our objectives are to obtain reasonable assurance about whether the standalone financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these standalone financial statements.



As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the standalone financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances. Under Section 143(3)(i) of the Act, we are also responsible for expressing our opinion on whether the company has adequate internal financial controls with reference to standalone financial statements in place and the operating effectiveness of such controls.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the standalone financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditors' report. However, future events or conditions may cause the Company to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the standalone financial statements, including the disclosures, and whether the standalone financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

Materiality is the magnitude of misstatements in the standalone financial statements that, individually or in aggregate, makes it probable that the economic decisions of a reasonably knowledgeable user of the standalone financial statements may be influenced. We consider quantitative materiality and qualitative factors in (i) planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the standalone financial statements.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the standalone financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditors' report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a



matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

- h) With respect to the other matters to be included in the Auditors' Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, in our opinion and to the best of our information and according to the explanations given to us:
  - i. The Company has disclosed the impact of pending litigations as at 31 March 2024 on its financial position in its standalone financial statements.
  - ii. The Company does not have any long term contracts including derivative contracts requiring a provision for material foreseeable losses.
  - iii. There has been no delay in transferring amounts, required to be transferred, to the Investor Education and Protection Fund by the Company.
  - iv. (a) The Management has represented that, to the best of its knowledge and belief, no funds (which are material either individually or in the aggregate) have been advanced or loaned or

In our opinion and according to the information and explanations given to us, the remuneration paid by the Company to its directors during the current year is in accordance with the provisions of Section 197 read with Schedule V of the Act. The remuneration paid to any director is not in excess of the limit laid down under Section 197 of the Act. **NOTES FORMING PART OF THE FINANCIAL STATEMENTS****Note no. 1 : Significant Accounting Policies****(A) (i) Basis of Accounting:**

The Financial Statements have been prepared on the accrual basis of accounting, in Accordance with generally accepted accounting principles including the Accounting Standards notified under the Sec.133 of the Companies Act, 2013, read with Rule 7 of the Companies (Accounts) Rules 2014.

The financial statements have been prepared on a historical cost basis.



The financial statements are presented in Indian Rupees (INR) and all values are rounded to nearest lakhs (₹00,000), except where otherwise indicated.

The financial statements are approved for issue by the Company's Board of Directors on May 29, 2024.

**(ii) Consistency:**

Accounting Policies not specifically referred to otherwise are consistent and are in consonance with generally accepted accounting principles.

**(iii) Current v. Non-Current classification:**

The Company presents assets and liabilities in the balance sheet based on current/non-current classification.

**(a) An asset is treated as current when it is:**

- Expected to be realized or intended to be sold or consumed in normal operating cycle,
- Held primarily for purpose of trading, or
- Expected to be realized within twelve months after the reporting period.

All other assets are classified as non-current.

**(b) A liability is current when:**

- It is expected to be settled in normal operating cycle,
- It is held primarily for purpose of trading,
- It is due to be settled within twelve months after the reporting period, or
- There is no unconditional right to defer the settlement of the liability for at least twelve months after the reporting period.

All other liabilities are classified as non-current.

- (iv) Use of Estimates, Assumptions and Judgments:** The preparation of financial statements requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent liabilities on the date of the financial statements and the results of operations during the year. Differences between actual results and estimates are recognized in the year in which the results are known or materialize. Estimates and underlying assumptions are reviewed on an ongoing basis.

- (B) Inventories:** Inventories consist of raw materials, packing materials, work-in-progress and finished goods. Inventories are valued at lower of cost and net realizable value. Cost is determined on First-In-First-Out basis.





(i) Cost of raw materials and packing materials includes cost of purchase and other costs incurred in bringing the inventories to their present location and condition.

**(ii) Valuation of Closing Stock of Finished Goods & Work-in-progress:**

The inventory at the year-end is valued at Cost or Net Realizable Value whichever is lower.

Cost of work-in-progress and finished goods include direct materials, labour and proportion of manufacturing overheads based on the normal operating capacity, wherever applicable.

Net realizable value is the estimated selling price in the ordinary course of business, less estimated cost of completion and estimated costs necessary to make the sale.

The inventories have been physically taken by the management periodically during the year.

**(C) Cash Flow:**

Cash Flow Statement has been prepared on the basis of 'Indirect Method' as prescribed under AS-3.

**(D) Provisions, Contingent Liabilities and Commitments:**

(i) Provisions are recognized when there is a present obligation (legal or constructive) as a result of a past event and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

The company has provided for a Provision for doubtful debt of Rs.20,35,512.

(ii) The expenses relating to a provision is presented in the Statement of Profit and Loss net of reimbursements, if any.

(iii) If the effect of the time value of money is material, provisions are to be discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is proposed to be used, the increase in provision due to the passage of time is recognized as a finance cost.

(iv) Contingent liabilities are possible obligations whose existence will only be confirmed by future events not wholly within the control of the Company, or present obligations where it is not probable that an outflow of resources will be required or the amount of the obligation cannot be measured with sufficient reliability.

(v) Contingent liabilities are not recognized in the financial statements but are disclosed unless the possibility of an outflow of economic resources is considered remote.

**(E) Prior Period Items:**

An expense relating to prior period has been charged to current year profit and loss statement and a separate disclosure for the same has been made.

**(F) Revenue Recognition:**

Sales are recognized at the time when the risks and rewards as regards those good are transferred to the buyer, and include Excise duty, Education cess duty, Secondary higher education cess, Sales Tax and Goods & Service tax, wherever applicable.

**(G) Property, Plant & Equipment AS – 10:**

- i. Property, plant and equipment are stated at cost, net of accumulated depreciation and accumulated impairment losses, if any.
- ii. The initial cost of an asset comprises its purchase price, any costs directly attributable to bringing the asset into its present location and condition, necessary for it to get ready for its intended use.
- iii. Subsequent expenditure is capitalized only if it is probable that the future economic benefits associated with the expenditure will flow to the Company.
- iv. Spare parts, which meet the definition of Property, plant and equipment, are capitalized as Property, plant and equipment. In other cases, the spare parts are inventorised on procurement and charged to Statement of Profit and Loss at the time of consumption.
- v. The residual values, useful lives and methods of depreciation of property, plant and equipment are reviewed at each financial year end and adjusted prospectively, if appropriate. The useful lives for various categories of property, plant and equipment are as given below:
