Sub: Suspension of trading in securities

Pursuant to the provisions of SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (“SOP Circular”) with respect to Standard Operating Procedure for suspension and revocation of trading of shares of listed entities for non-compliance with certain regulations of SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015 (“Listing Regulations”), it is hereby informed that the following Company has not complied with requirements of Regulation 17(1) (i.e. Composition of Board) of the Listing Regulations for two consecutive quarters’ i.e. June 30, 2022 and September 30, 2022. Hence, the trading in securities of below mentioned company will be suspended w.e.f. February 17, 2023, if the below mentioned company fails to comply on or before February 14, 2023. Details are as under:

Further if the above-mentioned companies do not comply as per the provisions of SOP Circular on or before **February 14, 2023**, then:

- After 15 days of suspension, trading in the securities of non-compliant Company would be allowed on Trade for Trade basis in (Z category) on the first trading day of every week for six months.
