Login with older version NEAT+ 7.3.6 shall be discontinued from July 04, 2020 and members shall be able to login only with versions NEAT+ 7.3.7 and NEAT+ 7.3.8.

Login with the version NEAT+ 7.3.7 shall be discontinued from August 08, 2020 (Mock).

The mock is being held only for internal purpose, however, Members who voluntarily want to participate may do so by following instructions as provided in Annexure 1. Members not desirous of participating in the mock session, should take care to ensure that their internal systems are accordingly tuned for not participating in the mock.

Important instructions / General Guidelines regarding INTERNAL MOCK trading session

- 1. Refer to Exchange circular download ref no NSE/MSD/40008 dated January 22, 2019 for Interactive Connectivity Parameters.
- 2. Installation procedure for NEAT and NEAT+ is available on extranet path /common/Installation\_Procedure.
- 3. Members are requested to note that the Exchange Contingency Tests shall be carried out as per the timing mentioned above including market pre-open after index based market wide circuit breach. Members are requested to plan their activities accordingly.
- 4. All the outstanding orders shall be purged before the start of each trading session. Members using NNF software should clear the outstanding orders in their systems before the start of each trading session.
- 5. Trades resulting from this session shall not attract any obligation in terms of funds pay-in and/or pay-out.
- 6. Members are requested to note that NOTIS application shall not be available during the mock session.
- 7. All members eligible to trade in CM segment in live market are enabled for participating in the mock trading sessions with their existing user ids, IP and Box Id mapping that of the live environment.

## NEATPLUS - Closeout Offline Order Entry

In order to enable clearing member to place multiple closeout orders a file upload facility has been introduced as follows. This facility is in addition to the current close out order entry window.

- 1. The facility is available to corporate manager of Clearing Members (PCM & PCM+TM).
- 2. The window can be invoked through Menu Item "Closeout Offline Order Entry" or through CTRL+SHIFT+W key stroke.
- 3. Additional details of the said facility including the order entry file format are provided in NEATPlus in Help menu (Alt + F1) / Closeout Offline Order Entry.
