Enhancement in process of enrollment of unregistered participants on CBRICS

Corporate Bond Reporting and Integrated Clearing System (CBRICS) platform of NSE enables participants to report their transactions in corporate bonds. As per current process, enrollment of unregistered participant is undertaken manually by Registered Participants. In order to enroll an unregistered participant, the registered participant needs to submit an application providing details of the unregistered participant and upload supporting documents for verification of Participant code, Participant name, PAN, Bank account details and DP details. Upon successful verification of details by Exchange, the enrollment of unregistered participant is completed, thereby enabling reporting of deal by registered participant in CBRICS system. In case of mismatch, the application is returned to registered participant along with reasons. Based on this the registered participant shall either need to rectify the details submitted or upload revised supporting documents for re-verification.

In order to enhance and simplify the enrollment of unregistered participants, Exchange is pleased to announce introduction of bulk upload and API facility. Participants may refer to Annexure A for format of bulk upload. For latest version of CBRICS API, participants may kindly refer to "Protocol documents for WEB based interfaces" on website link https://www.nseindia.com/trade/platform-services-neat-trading-system-protocols.

Accordingly, Registered Participants may enroll unregistered participants through the following modes:

- 1. Non-API users Manual entry (Users accessing through CBRICS application)
- 2. Non-API users Bulk upload (Users accessing through CBRICS application)
- 3. API users (Submit through API)

Upon submission of enrolment application, the following details shall be verified by Exchange:

- a. Bank details verification through 2 independent API processes:
 - Participant's Name + Participant's PAN
 - Participant's Name + Participant's Bank account details (Penny drop verification)

The above combinations shall be verified and approved or returned (along with reasons), based on the match score of name. As per current configuration, the match score is set as "100".

b. Depository details verification through API process: The verification of DP id, client id and PAN shall be undertaken through integration with Depositories.

All mis-matched applications shall be displayed to registered participant in the "Returned" Tab in CBRICS until actioned further. Registered Participants shall need to rectify the discrepancy via CBRICS front-end.



API facility shall not be available for rectification of mismatch other than mismatch arising out of typographical error.

In order to avoid failure due to mismatched cases, Registered Participants are required to exercise utmost care and ensure that the participant details submitted for enrolment match with the data available at source of verification i.e. Bank and Depository.

For ease of reference, ready reckoner of the process is given below:
