This is in reference to Exchange circular NSE/MSD/54422 dated November 14, 2022, NSE/MSD/55276 dated January 17, 2023 and NSE/MSD/56654 dated May 09, 2023 regarding Standardisation of file formats for MII-Member Interface with ISO Tags.
