Re: Initial public offering of Stove Kraft Limited (the "Company") of equity shares of face value of ₹10 each (the "Equity Shares") comprising a fresh issue of such number of Equity Shares aggregating up to ₹950.00 million and an offer for sale of up to 8,250,000 Equity Shares by the Selling Shareholders (the "Offer").

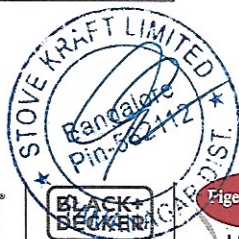
