In non-automotive sector, we cater to manufacturers of Defense, Marine & Telecommunication Infrastructure industries. At present, our core expertise lies in serving the automotive industry.

- Our business is dependent on the performance of the automotive industry. Economic cyclicality coupled with reduced demand in these other industries, in India or globally, could adversely affect our business, results of operations and financial condition.
- We do not have long-term agreements with our suppliers for raw materials and an inability to procure the desired quality, quantity of our raw materials in a timely manner and at reasonable costs, or at all, may have a negative impact on our business, results of operations, financial condition and cash flows



भारत जांच में सहयोग नहीं कर रहा: अमेरिका

अमेरिकी विदेश मंत्रालय के प्रवक्ता मैथ्यू मिलर ने कनाडा मामले में रखा अमेरिका का पक्ष

अमेरिका में मंगलवार को आरोप लगाया कि भारत पिछले साल एक सिख अलगाववादी की हत्या के मामले में कनाडा की जांच में सहयोग नहीं कर रहा है। अमेरिकी विदेश मंत्रालय के प्रवक्ता मैथ्यू मिलर ने अपने दैनिक संवाददाता सम्मेलन में कहा, "कनाडा के मामले की बात करें तो हमने स्पष्ट कर दिया है कि आरोप बेहद गंभीर हैं और उन्हें गंभीरता से लिया जाना चाहिए। हम चाहते थे कि भारत सरकार कनाडा के साथ जांच में सहयोग करे। जाहिर है, उन्होंने वह रास्ता नहीं चुना है।"

कनाडा के प्रधानमंत्री जस्टिन ट्रूडो ने एक दिन पहले आरोप लगाया था कि पिछले साल जून में सरें में सिख अलगाववादी हरदीप सिंह निजजर की हत्या में भारत सरकार के अधिकारी शामिल थे। ट्रूडो ने आरोप लगाया, "देश के राष्ट्रपति पुरातन बल रावल कनाडाईयन माटेडर्ड पुलिस (आरोपपूर्ण) के पास स्पष्ट और पुष्टा सबूत हैं कि भारत सरकार के एफटीसी गतिविधियों में शामिल रहे हैं और अभी भी शामिल हैं जो सार्वजनिक सुरक्षा के लिए एक बड़ा खतरा हैं। इसमें गुप्त सूचना एकत्र करने की तकनीक, दक्षिण

एशियाई कनाडाई लोगों को निशाना बनाने वाला बलपूर्वक व्यवहार और हत्या सहित एक दर्जन से अधिक धमकी भरी और हिंसक कृत्यों में शामिल होना शामिल है। यह अव्यक्त है।"

इन आरोपों को खारिज करते हुए भारत ने न केवल कनाडा से अपने उच्चायुक्त को वापस बुला लिया, बल्कि नई दिल्ली से उसके छह राजनयिकों को भी निष्काशित कर दिया। विदेश मंत्रालय (एमईए) ने कहा, "सितंबर 2023 में प्रधानमंत्री ट्रूडो द्वारा कुछ आरोप लगाए जाने के बाद से कनाडा सरकार ने हमारी ओर से कई अनुरोधों के बावजूद भारत सरकार के साथ एक भी सबूत साझा नहीं किया है। यह हालिया कदम उन बातों के बाद उठाया गया है जिसमें फिर से बिना किसी तथ्य के दवावे किए गए हैं। इससे इस बात में कोई संदेह नहीं रह जाता कि यह जांच के बहाने राजनीतिक लक्ष्य के लिए जानबूझकर भारत को बदनाम करने की एक रणनीति है।"

विदेश मंत्रालय ने कहा, "प्रधानमंत्री ट्रूडो का भारत के प्रति शत्रुपूर्ण रुख लंबे समय से देखने को मिल रहा है। ट्रूडो ने 2018 में भारत की यात्रा की थी जिसका मकसद वोट

वैक को साधना था, लेकिन यह यात्रा उन्हें असहज करने वाली साबित हुई। उनके मंत्रिमंडल में ऐसे व्यक्ति शामिल हैं, जो भारत को लेकर चरमपंथी और अलगाववादी एजेंडे से खुले तौर पर जुड़े हुए हैं। दिसंबर 2020 में भारत को अंतरिम राजनीति में उनका स्पष्ट हस्तक्षेप दिखाता है कि वह इस संबंध में कहां तब जाना चाहते थे। मंत्रालय ने कहा, "उनकी सरकार एक राजनीतिक दल पर निर्भर थी, जिसके नेता भारत के खिलाफ खुले आम अलगाववादी

विचारधारा का समर्थन करते हैं जिससे मामला और बिगड़ गया। कनाडा की राजनीति में विदेशी हस्तक्षेप को नजर अंदाज करने के लिए आलोचना खेल रही उस सरकार ने नुकसान को कम करने के प्रयास में जानबूझकर भारत को शामिल किया है। भारतीय राजनयिकों को निशाना बनाने वाला यह ताजा घटनाक्रम अब उसी दिशा में अमला कदम है। यह कोई संयोग नहीं है कि यह उस समय हुआ है जब प्रधानमंत्री ट्रूडो को विदेशी हस्तक्षेप पर एक आयोग के समक्ष

गवाही देनी है। यह भारत विरोधी अलगाववादी एजेंडे को भी बढ़ावा देता है जिसे ट्रूडो सरकार ने संकीर्ण राजनीतिक लाभ के लिए लगातार बढ़ावा दिया है।"

भारत ने कहा कि ट्रूडो सरकार ने कनाडा में भारतीय राजनयिकों और समुदाय के नेताओं को परेशान करने, धमकाने और भयभीत करने के इरादे से जानबूझकर हिंसक चरमपंथियों और आतंकवादियों को अपने यहां आश्रय दिया है। मंत्रालय ने कहा, "हमारे राजनयिकों और भारतीय नेताओं को जान से मारने की धमकियां देना भी शामिल है। इन सभी गतिविधियों को अभिव्यक्ति की स्वतंत्रता के नाम पर उचित ठहराया गया है। कनाडा में अवैध रूप से प्रवेश करने वाले कुछ व्यक्तियों को नागरिकता देने के लिए तैयारी से काम किया गया। कनाडा में रहने वाले आतंकवादियों और संगठित अपराध के नेताओं के संबंध में भारत सरकार की ओर से कई प्रत्यर्पण अनुरोधों की अनदेखी की गई है।"

हालांकि, अमेरिका में भारत-कनाडा कूटनीतिक विवाद पर टिप्पणी करने से पहले कनाडा मंत्रालय ने कहा, "मैं इस पर कोई टिप्पणी नहीं करना चाहता। लेकिन जैसा कि हमने पहले कहा है, ये गंभीर आरोप हैं। हम चाहते हैं कि भारत इन्हें गंभीरता से ले तथ्य कनाडा की जांच में सहयोग करे। लेकिन उन्होंने दूसरा रास्ता चुना है।" भाषा

ब्रिटेन ने कनाडा विवाद पर कहा

भारत का सहयोग अगला सही कदम है

ब्रिटेन ने भारत और कनाडा के बीच जारी राजनयिक विवाद के संदर्भ में बुधवार को कहा कि कनाडा की कानूनी प्रक्रिया के साथ भारत सरकार का सहयोग "गंभीर घटनाक्रम" पर अगला सही कदम है। विदेश, राष्ट्रमंडल और विकास कालिया (एफसीडीओ) ने लंदन में एक बयान में कहा कि वह "भारत सरकार से जुड़ी कनाडाई जांच" को लेकर कनाडा के साक्षरों के संकेत में है और उसने कनाडा की न्यायिक प्रणाली पर विश्वास जताया।

यह बयान तब आया है जब इससे पहले भारत ने कनाडा के छह राजनयिकों को निष्काशित कर दिया और कनाडा में अपने उच्चायुक्त राज कृष्ण कुमार वर्मा को वापस बुला लिया।

भारत ने इस सप्ताह की शुरुआत में कनाडा के आरोपों की "बेतुका" बताते हुए उन्हें जस्टिन ट्रूडो सरकार के राजनीतिक एजेंडे से जुड़ा बताया, जो वोट बैंक की राजनीति

पर केंद्रित है। एफसीडीओ के बयान से दो दिन पहले ब्रिटेन के प्रधानमंत्री कियर स्टार्मर ने सोमवार को कनाडा के प्रधानमंत्री जस्टिन ट्रूडो से फोन पर बातचीत की थी। ब्रिटेन और कनाडा "फाइव आइज" नामक एक गठबंधन का हिस्सा हैं जिसमें ऑस्ट्रेलिया, न्यूजीलैंड और अमेरिका भी शामिल हैं। एफसीडीओ के एक प्रवक्ता ने कहा, "हम कनाडा में स्वतंत्र जांच में सामने आए गंभीर घटनाक्रम को लेकर अपने कनाडाई साक्षरों के संकेत में हैं।" भाषा

छात्रों की रुचि दूसरे देशों में

भारत और कनाडा के बीच ताजा राजनयिक विवाद का असर उत्तरी अमेरिकी देश में उच्च शिक्षा हासिल करने का खाब देखने वाले छात्रों पर पड़ सकता है। करियर सलाहकार कहते हैं कि पढ़ाई के लिए कनाडा जाने वाली की



जितन चावला भी इससे सक्षम दिखाई दिए। उन्होंने कहा, "कनाडा में पिछले कुछ सालों में हालात तेजी से बदल रहे हैं और छात्र अब फिनलैंड, नीदरलैंड और जापान जैसे विकल्पों पर विचार करने लगे हैं, क्योंकि इन देशों में करियर को लेकर फायदे और स्थिरता जैसे बड़े भरसा जागते हैं।"

कनाडा जाने वालों की संख्या हाल के दिनों में बहुत तेजी से घटी है। छात्रों से संबंधित संवाद करने वाली कंपनी कलेजीफाई के संस्थापक और सीईओ आदर शिंदेवाला कहते हैं, "कनाडा जाने के लिए पिछले साल तक हमें वार्षिक कर 400 से 500 आवेदन मिलते थे, लेकिन इन वर्षों यह संख्या 70 पर सिमट गई है। ये भी कुछ बड़े विश्वविद्यालयों के लिए ही है। मध्यम स्तर के कलेजों में पढ़ने जाने की तैयारी कर रहे छात्रों ने अपनी योजना बदल दी है।" खंडेवाला कहते हैं कि स्नातक स्तर की शिक्षा के मामले में अधिकांशों का फैसला काफी महत्वपूर्ण होता है। इसलिए ताजा विवाद ने उन्हें सोचने के लिए मजबूर कर दिया है। उन्होंने यह भी कहा कि रहने-खाने का खर्च बढ़ने और यहां बेहतर अवसरों की कमी हो जाने के कारण भी लोग अपने फैसले बदल रहे हैं। दिल्ली स्थित सेंटर फॉर करियर डेवलपमेंट में करियर काउंसलर

अनंजलाना यात्रा करने वाली फिकोयोटेल के सह संस्थापक हरि गणपति कहते हैं, "भारत और कनाडा के बीच हालिया घटनाओं के बाद निश्चित रूप से लोग दूसरे विकल्पों के बारे में विचार करने लगे हैं। वे अपनी छुट्टियां तनाव मुक्त माहौल में गुजाना चाहते हैं। इस समय लोग ऑस्ट्रेलिया और दूसरे उत्तरी देशों में जाना परसंद कर रहे हैं।" इसी साल सितंबर में कनाडा की सरकार ने 2025 के लिए अंतरराष्ट्रीय स्टडी परमिट की संख्या में कमी करने का एलान किया था। इसमें अंतरराष्ट्रीय स्टडी परमिट 2024 के लक्ष्य 4,85,000 से घटकर 2025 के लक्ष्य 4,37,000 करने की बात कही गई थी। भारत से बढ़ी संख्या में छात्र कनाडा पहुंचने जाते हैं। विदेश मंत्रालय के आंकड़ों से पता चलता है कि 2021 में 2,16,360 छात्र कनाडा गए थे, जबकि 2022 में यह संख्या बढ़कर 3,18,380 और 2023 में 4,27,085 हो गई।

बीजा मामले निपटाने में लगा रहा अधिक समय

भारत और कनाडा के बीच बिगड़ते रिश्तों का असर आम लोगों पर भी पड़ रहा है। अनेक भारतीय अवासन, वर्क और छात्र बीजा को लेकर ऊहापूहा की स्थिति में हैं। विश्वेपुको का मानना है कि ताजा राजनयिक विवाद बीजा नौत को सीधे प्रभावित नहीं करेगा। मर्केल ऑफ काउंसिल में पॉटरन रसेल ए स्ट्रेटेजी ने कहा, "यह समझना जरूरी है कि भारत और कनाडा के बीच जारी गतिरोध का असर अवासन पर पड़ नहीं पड़ेगा जा रहा है। भू-राजनीतिक मामलों में कनाडा ऐसे मुद्दों को अलग ही रखता है।"

राजनयिक विवाद की जड़ कुछ अज्ञात हालातवर्तों ने कनाडा में एक गुरुद्वारे के बाहर खालिस्तान समर्थक हरदीप सिंह निजजर की हत्या कर दी थी। पिछले साल कनाडा के प्रधानमंत्री जस्टिन ट्रूडो ने इस हत्याकांड में भारत सरकार की संलिप्तता के आरोप लगाए थे। भारत ने न केवल इन आरोपों का खंडन किया था बल्कि ऐसा नहीं करने के लिए ट्रूडो को चेतावा भी था। यह विवाद पिछले सोमवार को उस समय और गहरा गया जब भारतीय विदेश मंत्रालय के मिले एक राजनयिक पत्र में यह संकेत दिया गया कि निजजर हत्याकांड की जांच में शक की सूरी भारतीय उच्चायोग के अधिकारियों पर भी जा रही है और उनसे पूछताछ की जा सकती है। इसके

बाद भारत ने कनाडाई राजदूत को बुलाकर चेतावा और उसके राजनयिकों को देश छोड़ने के लिए कहा दिया और सुरक्षा का हवाला देकर कनाडा से अपने राजनयिक और अधिकारियों को दिल्ली बुला लिया।

घर से दूर घर जैसा माहौल कनाडा में लाखों भारतीय नागरिक रहते हैं, जो यहाँ निधन कानों से अर्थव्यवस्था को गति दे रहे हैं। भारतीयों को कनाडा का माहौल अपने घर जैसा ही लगता है। यही कारण है कि छात्र पढ़ाई के लिए अन्य देशों के मुकाबले कनाडा के ही विश्वविद्यालयों में दाखिला लेने की प्राथमिकता देते हैं। अन्य देशों के मुकाबले यहां उन्हें कम दिक्कतें होती हैं और हर मोड़ पर कोई न कोई अपने देश का नागरिक मिल जाता है।

विवाद का भारतीयों पर असर यद्यपि अवासन नीतियों में कोई आधिकारिक बदलाव नहीं हुआ है, लेकिन भारत में कनाडाई राजनयिकों की संख्या घट जाने से बीजा मामले निपटाने में काफी देर ला रही है। अवासन सलाहकार और अभिनव इमिग्रेशन सर्विसेज के संस्थापक अजय शर्मा कहते हैं, "इस देरी से खले बीजा मामलों को संभालने में कनाडा के अधिकारियों को राहत मिली हो, लेकिन यात्रा की तैयारी कर रहे भारतीय इससे बुरी तरह प्रभावित हो रहे हैं।" यदि यही स्थिति रही तो इसका असर



विजिटर और वर्क बीजा, दोनों पर पड़ेगा।

छात्रों के लिए चिंता का विषय? कनाडा में पढ़ रहे भारतीय छात्रों को बदलते हालात से अधिक चिंता करने की जरूरत नहीं है, क्योंकि इससे उनका मौजूदा स्थिति पर कोई असर नहीं पड़ेगा जा रहा है। कनाडा के विश्वविद्यालय कठिन समय में अपने यहां पढ़ने वाले विदेशी छात्रों की मदद करने के लिए जाने जाते हैं। करियर मौजके के संस्थापक और निदेशक अभिजित जखेरी कहते हैं, "कनाडाई संस्थानों के पास विदेशी छात्रों को संभालने के लिए मजबूत ढांचा है।" शर्मा कहते हैं, "विवाद के कारण उजड़े हालात में बीजा मिलने में देर का असर उन छात्रों पर पड़ सकता है, जिन्हें अभी बांध अपनी पढ़ाई शुरू करनी है, क्योंकि इससे उनका कोर्स पिछड़ जाएगा। साथ

ही ऐसे लोग भी परेशान होंगे जो कनाडा में पढ़ रहे अपने बच्चों से मिलने जाना चाहते हैं।"

कार्य स्थलों पर व्यवहार

विशेषज्ञों का मानना है कि कनाडा में काम कर रहे लोगों को कार्य स्थल पर किसी भी तरह के उपेक्षित या अन्य परेशानी के बारे में चिंता करने की कोई जरूरत नहीं है। वनस्ट्रेप ग्लोबल के संस्थापक और निदेशक अश्विनी चौधरी के अनुसार, "कनाडा में काम करने वाली बहुराष्ट्रीय कंपनियों विविधता और समावेशीता को बढ़ावा देने के लिए प्रतिबद्ध हैं। इसलिए यहां का माहौल प्रभावित होने का खतरा नहीं है, लेकिन छोटे कारोबार में कार्यरत लोगों को थोड़ी-बहुत दिक्कतों का सामना करना पड़ सकता है। हालांकि इस बारे में अभी कुछ भी कहना बहुत जल्दबाजी होगी।"

कनाडा जाने वालों की संख्या कम होगी? यह 2022 में विदेशी छात्रों ने कनाडा की अर्थव्यवस्था में लगभग 37.3 अरब डॉलर का योगदान दिया था। वहां कुशल कामगारों की बहुत अधिक जरूरत है, जिसकी पूर्ति वह विदेशी छात्रों से करता है। कनाडा में रहने वाले इमिग्रेशन विश्लेषक दर्शन महाराज कहते हैं, "ताजा विवाद अप्रवासन को बहुत अधिक समय तक प्रभावित नहीं कर पाएगा। अच्छे संबंधों से दोनों ही देशों को फायदा है।"
