Press reports regarding M/s. Shipping Corporation Of India Ltd.

The press had reports on October 06, 2005 that the Government is likely to offload its 15% stake in Shipping Corporation Of India Limited through second public issue.

The Exchange, in order to verify the accuracy or otherwise of the information reported in the press and to inform the market place so that the interest of the investors is safeguarded, had written to the officials of the company.

Shipping Corporation Of India Limited has vide its letter inter-alia stated, "The Company has not received any communication from the Government with regard to 15% offloading of Government stake in the company".

Press reports regarding M/s. Morepen Laboratories Ltd.

The press had reports on October 07, 2005 that Morepen Laboratories Ltd. is in advanced stages of negotiations with a foreign investor who would bring in Rs. 60 crore, part of which would be utilised to clear the dues of small depositors.

The Exchange, in order to verify the accuracy or otherwise of the information reported in the press and to inform the market place so that the interest of the investors is safeguarded, had written to the officials of the company.

Morepen Laboratories Limited has vide its letter inter-alia stated, "In the above context, we may inform you that we had a close door meeting with Hon'ble Company Law Board on 5th October, 2005. The news item appears to be based on some of the issues which were discussed. A mention was made by our representative that the Company has been talking with Foreign Investor. However, nothing has been finalized yet".
