Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015 read with SEBI circular No. SEBI/H0/CFD/CMD1/CIR/P/2020/84 dated 20th May, 2020 and with reference to our earlier relevant disclosure on the subject, following are the brief details relating to impact of COVID-19 pandemic and resultant lockdown, on the operations/performances of the Company:

Material impact of COVID-19 pandemic on the operations and performance of the Company

1. Impact of COVID-19 pandemic on the business:

Our plant was closed till April 21, 2020 due to lockdown. We got permission on April 22, 2020 from concerned authorities, subject to fulfillment of certain conditions, to partially start manufacturing operation to meet the export orders backlog.

2. Ability to maintain operations including factories/ units/ office space functioning and close down:

- i) We are pleased to inform you that we have started operations at our plant located at Chhatral. We are observing full compliance to the conditions of operations stipulated to prevent the spread of COVID-19 disease;
- ii) We are not facing much labor issues as most of our laborers are from nearby villages;
- iii) Our Head office at Ahmedabad is functioning, subject to maintaining adequate social distancing and other required safety norms in this regards;
- iv) We have also provided work from home facility to the employees of the Head office who are staying in containment zones.

3. Schedule, if any, for restarting the operations:

We had already communicated the resumption of operations/productions at the manufacturing plant w.e.f 22^{nd} April, 2020 after obtaining requisite approval from the concerned authorities and we are scaling up the production/manufacturing capacity of the company gradually.

4. Steps taken to ensure smooth functioning of operations:

- i) We are taking necessary preventive measures like social distancing, temperature testing with thermal screening gun, providing mask and facility of sanitizing tunnel is also installed for the workers to avoid the infection due to COVID-19;
- ii) We have sufficient export and domestic orders in hand to scale up the production capacity utilization;
- iii) We have sufficient stock of Raw material to meet the production requirements.
- iv) We being a 'Responsible and Caring brand' has been proactive in supporting various government initiatives and helping communities around us;
- v) We have instructed all our employees to download the *Arogya Setu* applaunched by Government of India.


5. Estimation of the future impact of COVID-19 pandemic on the operations:
