I, Mohan D Baid, Practicing Company Secretary, at 2005-A, Rathi Palace, Ring Road, Surat-395002, Gujarat, India, appointed as Scrutinizer by the Board of Directors of Anupam Rasayan India Limited ("the Company") for the purpose of scrutinizing the postal ballot through remote E-voting pursuant to Section 108 and 110 of the Companies Act, 2013 read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014 (Amendment Rules, 2015) and applicable Listing Regulations in respect of the below mentioned resolution proposed to be passed through postal ballot only through remote E-voting of the Equity Shareholders of the Company which commenced on 28.05.2022 and closed on 26.06.2022. - 1. - 3. The Equity Shareholders holding shares as on May 25, 2022, "cut-off date", were entitled to vote on the resolution stated in the Postal Ballot Notice.
- 4. In accordance with the Notice of Postal Ballot and the 'Advertisement' published pursuant to Rule 20(4)(v) of the Companies (Management and Administration) Rules, 2014 (Amendment Rules 2015) on May 28, 2022, the postal ballot through remote E-voting commenced at 9:00 AM on May 28, 2022 and closed at 5:00 PM on June 26, 2022.
- 5. The postal ballot through remote E-voting was provided by National Securities Depository Limited (NSDL).
- After closure of remote E-voting, the votes were unblocked at Surat on Monday, June 27, 2021 and downloaded from the e-voting website of NSDL. The e-voting data/ results downloaded from the e-voting system of NSDL were scrutinized and reviewed.


