




#### **Revenue from Operations**



### **Earning Before Tax**




## **Earning Per Share**






### **Earning Before tax**

- It is planned that over a period of three years, assistance will be provided to one crore farmers to adopt natural farming methods. Additionally, 10,000 bio input resource centers will be established


## Product launch
