Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015, as amended from time to time ("SEBI LODR"), we hereby inform you that M/s. Sharp & Tannan, Chartered Accountants, (ICAI Firm Registration No. 109982W), appointed as Statutory Auditors of the Company for a period of five years from the conclusion of AGM held on 11<sup>th</sup> August 2016, shall complete their present term on conclusion of the ensuing AGM i.e. on 23<sup>rd</sup> July, 2021.

In order to avoid any controversy arising from differing legal views about their eligibility for reappointment and to uphold their high governance standards, M/s Sharp & Tannan, Statutory Auditors vide their letter dated 14<sup>th</sup> July, 2021 to the Company, have withdrawn their consent to be re-appointed as Statutory Auditors of the Company. The Audit Committee noted that the withdrawal of consent was due to the reasons stated above and not due to any other concern or issue.

We wish to further inform you that based on the recommendation of the Audit Committee, the Board of Directors of the Company at its meeting held on 15<sup>th</sup> July, 2021 noted and accepted the withdrawal of consent by M/s Sharp & Tannan for the said re-appointment.

Accordingly, the proposed resolution item no 3 in relation to "Re-appointment of M/s Sharp & Tannan, Chartered Accountants, Statutory Auditors of the Company and to fix their remuneration" set out in the Notice dated 24<sup>th</sup> June, 2021 convening the 7<sup>th</sup> AGM of the Company scheduled to be held on Friday, 23<sup>rd</sup> July, 2021, is <u>withdrawn</u> and will not be transacted during the forthcoming AGM.

All other resolutions proposed for approval of the Members at the 7<sup>th</sup> AGM to be held on 23<sup>rd</sup> July, 2021 would be taken up for voting as scheduled.
