In furtherance to our intimation dated 23<sup>rd</sup> May, 2022 and pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("SEBI Listing Regulations") this is to inform you that the Board of Directors ("Board") of Destiny Logistics & Infra Limited ("Company"), in its meeting held today, viz. Monday, 30<sup>th</sup> May, 2022 considered and approved the following: -

- Pursuant to Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended) the Statement of Standalone Audited Financial Results for the Half year and Year ended 31.03.2022. We have attached the copy of the Results and the Audit Report issued by M/s. Bijan Ghosh & Associates, Statutory Auditor of the Company.
- 2. Fund raising of an amount not exceeding Rs. 07,69,40,000/- (Rupees Seven Crores Sixty Nine Lakhs and Forty Thousand Only), through a Rights issue to the eligible equity shareholders of the Company as on Record date (to be notified subsequently), in accordance with applicable laws, including the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended, SEBI Listing Regulations, along with relevant circulars issued by the Securities and Exchange Board of India, Companies Act, 2013. ("Rights Issue").
- Constitution of the Rights issue Committee to proceed with the Rights issue and, inter-alia, decide the other terms and conditions of the Rights Issue, including deciding on the record date, determining the rights issue price, rights entitlement ratio, appointment of intermediaries and other related matters.
- 4. Increase in Authorised Share Capital from Rs. 10,00,000 (Rupees Ten Crores Only) to Rs. 16,00,00,000 (Rupees Sixteen Crores Only) and consequent amendment in the Capital Clause of the Memorandum of Association of the Company. The said resolutions are subject to approval in the EGM by the members of the Company.
