Sitharaman set to review govt banks' financials on Monday

Loan recovery, over ₹100 crore of bad loans to be assessed

New Delhi, 17 June

Union Finance Minister Nirmala Sitharaman will chair a meeting of public sector banks (PSBs) on Monday to review their financial performance, asset quality and recoveries from bad loans.

The meeting will be attended by the State Bank of India (SBI) chairman, and managing directors (MD) and chief executive officers (CEO) of other public sector banks, an official said.

The review would involve assessment of the business performance of state-owned leners, credit growth, asset quality, recovery from bad loans, and review of non-performing assets (NPAs) of over ₹100 crore, the official said. The centre will also evaluate capital raising plans of public sector lenders and efforts taken to improve investor relations.



Finance Minister Nirmala Sitharaman's review meet comes at a time when PSBs are turning pofitable

This comes at a time when public sector banks have turned profitable and are looking to tap the markets for raising capital instead of relying on the government to infuse funds.

Through the Enhanced Access and Service Excellence (EASE 5.0) reforms, public sector banks have also been asked

to focus on a three-year strategic roadmap, and emphasise on supporting small businesses and agriculture. The strategic roadmap for each PSB would focus on business growth, profitability, risk, customer service, operations, and capability building.

GoM set to submit interim report on **GST-exempt items**

No decision on rate rejig

SHRIMI CHOUDHARY New Delhi

A group of ministers (GoM), tasked by the Goods and Services Tax (GST) Council with looking at rate rationalisation, could not form a view on changes in GST rates and slabs. It is likely to submit an interim report to the Council on pruning the list of items that at present do not attract

In a virtual meeting on Friday, the ministerial panel headed by Karnataka Chief Minister Basavaraj Bommai is learnt to have deliberated upon GST exemptions, rate rejig, and correcting the inverted duty structure on value chains, among other matters.

"We reiterated our views on slab mergers and rationalising rate on certain products, however no conclusion has been taken," said two of the panel members.

In the meantime, the panel will try submit an interim report to the Council before the scheduled date, they said.

According to them, the panel will be meeting again on rate restructuring. "We are assessing the rate restructuring impact on revenue, in case the slabs are merged the slabs and the lower threshold is increased. By doing so, several aspects needs to be factored in, which could take some time," one of the member explained.

The Council meeting is slated to be held on June 28 and 29 in Srinagar. Business Standard had

Praveen Aggarwal, association CEO, said only 50 per cent of the global demand for paper straws, a large chunk of it is from Europe, was being met this year. "Despite paying a higher price for paper straws than we do for plastic straws. we estimate import can meet only 25 per cent of the demand in India till the end of the year. Because of

the global shortage, India comes low on the producers' priority."

While 30-40 per cent of the paper straws are manufactured in China, the rest comes from Indonesia and some countries in Europe. The prices, say FMCG companies, are two to three times higher than those of plastic straws. Being a temporary measure, companies have to absorb the cost. However, the permanent solution is to manufacture it in India, but, Aggarwal said, the delivery of the machines to manufacture them would take at least a year.

The July 1 ban is for 22 products, which, apart from plastic straws, include spoons, forks, and plates. However, according to Chauhan, 80 per cent of the integrated straws (straws attached to tetra packs) recycled in India are different from
