Edelweiss fund invests ₹500 cr in Jindal entity

It will provide a long-term solution to the PR Jindal group's capital needs

Edelweiss Special Opportunities Fund III has invested ₹500 crore in a promoter holding entity of Jindal SAW Ltd, the flagship of the PR Jindal group. The special situations fund has signed a structured finance deal in Chhattisgarh-based Siddeshwari Tradex Pvt. Ltd (STPL), the investment holding firm owned by the promoters of the PR Jindal group. The proceeds will be used for general corporate purposes, two people briefed on the deal told *VCCircle*.

"This financing provides a tailored long-term flexible solution to the capital needs of the group," said Vinay Awasthy, managing partner, Perigon Consiliario, the advisor to Jindal SAW on this deal.

The company and Edelweiss Group did not respond to requests for comments.

Jindal SAW supplies iron and steel pipes, fittings and accessories and has manufacturing facilities in India, the US, Europe and the UAE. It has a market capitalization of \$500 million and an annual turnover of \$1.5 billion.

P.R. Jindal is the eldest son of O.P. Jindal, the founder of the \$24-billion Jindal Group.

Incorporated in 2013, STPL makes saw pipes, generates electricity from waste and manufactures railway wagons. In addition to Jindal SAW, STPL has a significant holding in OP Jindal group companies such as JSW Steel, Jindal Steel and Power, JSW Energy Ltd, Jindal Stainless and Jindal Stainless (Hisar).

The market value of STPL investments stood at ₹8,099.40 crore as on 31 January, according to Care Ratings. In FY21, STPL increased its stake in Jindal SAW by 7.61% to 11.68% as at the end of March, according to Jindal SAW's annual report for

2020-21. Arti Jindal, wife of P.R. Jindal, is one of the directors on STPL.

STPL's loans and advances to subsidiaries increased from ₹991 crore as on 31 March 2019 to ₹1,285 crore one year later. Further, the corporate guarantees to its subsidiaries increased from ₹1,179 crore as on 31 March 2019 to ₹1,528 crore as on 31 January 2021, the report said.

"With dividend and interest income being the major sources of income for

momentum in India in recent years. This deal with STPL is likely the fourth investment made by Edelweiss Special Situations Fund III, the people mentioned above said. The other investments made by the fund could not be ascertained.

The fund had announced a final close at \$900 million (around ₹6,700 crore) in October 2020 with commitments from limited partners (LPs), including Ontario Teachers' Pension Plan Board (OTPPB), Florida's State Board of Administration

and Swedish pension fund AP4, it had said at that time.

Kotak Special Situations Fund has also been investing from its \$1 billion fund in a variety of structured investment situations, while Aventus Capital elevated Nilesh Dhedhi to the helm of its structured credit business in July. Dubai-based private equity fund Synergy Capital Corp. Llp, set up by a former executive of steelmaker ArcelorMittal, is making investments in India via credit and structured equity, *VCCircle* reported last week. True North, a mid-market private equity firm, has also initiated talks with LPs for commitments for its maiden credit fund.

Nazara acquires OpenPlay for ₹186.4 cr

Nazara Technologies Ltd on Friday said it has acquired 100% stake in Hyderabad-based skill gaming company OpenPlay Technologies for ₹186.4 crore as the gaming and sports media company looks to bolster its play in the real money gaming segment.

OpenPlay runs a multi-game consumer gaming platform under the 'Classic Games' brand which hosts skill-based games. This marks the second acquisition for Nazara in the skill-based real money space after the 2019 purchase of Halaplay.

OpenPlay is also Nazara's eighth acquisition till date, and its second after the company's public listing in March.

For Nazara, real-money gaming contributes 2-3% of overall revenue, with the firm choosing not to aggressively bet on the space in the past due to regulatory uncertainties.

"There was uncertainty in the regulatory landscape for

real-money and skill gaming, but some positives are emerging along with clarity. This is also giving us the confidence to look at this segment and build a sizeable real-money gaming business. We are very confident of the strong product innovation which OpenPlay brings on the table, and will look to scale our skill and real-money gaming business with this acquisition," said Manish Agarwal, chief executive officer, Nazara Technologies, in an interview with *Mint*.

Earlier this month, the Madras high court, struck down a February 2021 amendment to the Tamil Nadu Gaming Act, which banned online betting games like rummy and poker with stakes. Also, the Supreme Court in July dismissed a petition that alleged game format offered by fantasy sports platform Dream11 amounted to gambling.

"I'm excited to join the 'Friends of Nazara Network' and look forward to working closely with Nazara leadership

and the network to build India's largest vernacular social gaming and entertainment platform. Our technology complemented by Nazara's positioning in the gaming industry in India is the perfect combination for this endeavour," Sreeram Reddy Vanga, founder, OpenPlay Technologies.

Before OpenPlay, Vanga founded CozyGames, and scaled it to become one of the largest Bingo networks in the UK. In 2017, it was bought by multinational sports betting and gaming group, Entain.

OpenPlay has an annualized gross gaming revenue run rate of ₹80 crore, and is earnings before interest, taxes, depreciation, and amortization (EBITDA) positive, the company said.

Nazara is now betting on creating a software-as-a-service (SaaS)-based product for real-money gaming which will allow any platform to integrate and offer real-money games to its user base. It will also take this proposition to the US market as it looks to gain market share in North America.

Indiagold raises \$12 mn from PayU, others

Indiagold, an alternative gold loan platform, has secured \$12 million from PayU, the fintech arm of Prosus, and Alpha Wave Incubation fund, it said on Friday.

Better Tomorrow Ventures, 3one4 Capital, Rainmatter Capital and Leo Capital also participated in the round.

Indiagold, founded in 2020 by former Paytm executives Deepak Abbot and Nitin Misra, had raised around \$1.9 million in February from Leo Capital and angel investors, including Cred founder Kunal Shah.

The platform offers digital

gold and gold loan services, besides lockers to park gold jewellery to a million consumers in Indore and Delhi-NCR.

Indiagold will use the funds to expand its footprint in another 8-10 cities by the end of FY22, and hire talent. It is also planning to integrate with PayU's 'buy now, pay later' product

LazyPay to offer EMI-based purchase of digital gold. The deal, if inked, will also help PayU users buy digital gold. "At present, we have slightly over 1 million customers across our various digital gold

products. In spite of the second wave of covid, where we have seen demand for digital

gold purchase and loans come back. Our July-August volumes are better than the combined April-June quarter," said Misra. "We hit \$1 million monthly GMV (gross merchandise value) run rate for digital gold purchase on our platform, and we expect it to grow further," Abbot said.

Apart from its standard gold loan product, Indiagold also offers doorstep conversion of

digital gold to physical gold.

Indiagold offers doorstep locker services, wherein an executive visits customer's homes and helps them park physical gold in lockers. It also provides insurance for the assets, while allowing customers to take loans against the gold kept in lockers.

"By supporting businesses complementing our existing portfolio, we aim to achieve our vision of developing a fintech ecosystem that will meet the financial service needs of millions. PayU is excited to partner with Indiagold in its journey to digitally transform loans against gold," said Vijay Agichia, global head, strategy and growth, PayU.

Indian Oil plans to invest ₹1 tn over the next 4-5 years

Indian Oil Corp. Ltd plans to invest ₹1 trillion over the next four to five years, chairman Shrikant Madhav Vaidya said in his speech at the 62nd annual general meeting of India's largest refiner on Friday.

Indian Oil plans to add another 25 million tonnes per annum (mtpa) to its current capacity of 80.2 mtpa.

"Speaking about India's energy future and the related opportunities, forecast by various agencies see Indian fuel demand climbing to 400-450 million tonnes by 2040 from the present 250 million tonnes. This offers enough legroom for all forms of energy to coexist," Vaidya said. "In fact, to cater to that demand surge, we are aggressively rolling out new projects. These translate into refining capacity expansion of over 25 million metric tonnes per annum (mmtpa), including CPCL (Chennai Petroleum Corp. Ltd), and an investment commitment of close to ₹1 trillion over the next 4 to 5 years."

Indian Oil, which expects domestic demand for diesel to reach pre-covid-19 levels by Diwali, has a 32% share of the domestic market. This assumes importance given that energy consumption, especially electricity and refinery products, usually linked to overall demand in the economy.

"With the recovery in overall demand, refining and other related operational parameters have demonstrated an even more pronounced turnaround compared to the previous year," he added. "For the

first quarter of this fiscal year, Indian Oil achieved a refinery run of 88.6% as compared to 68.5% in Q1 of FY21. The sales volume of petrol has already crossed pre-covid level, with diesel likely to reach there in the next 2-3 months, say by Diwali."

As per rating agency ICRA Ltd, petrol and diesel consumption in India is expected to grow by 14% and 10%, respectively, in FY22. India is a key refining hub in Asia, with an installed capacity of over 249.36 mtpa. It has 23 refineries and seeks to grow its capacity to 400 mtpa by 2025.

Indian Oil is expanding its petrochemical business in view of growing demand. It is in talks with Russia's largest integrated petrochemicals firm PJSC SIBUR Holding to set up a large petrochemical facility in India, *Mint* had reported earlier.

"To strengthen our company's long-term future, we are focusing on optimally integrating current refining processes to yield more chemical products per barrel of oil. This will intensify petrochemical and lubricant integration, leading to a diversified product portfolio and attain profit maximization," Vaidya said.

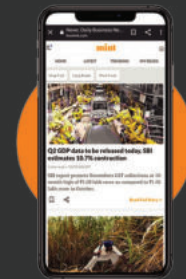
