We refer to your email dt. 14/03/2023 and wish to clarify as under:

- 1) Concerning the Re-submission of the quarterly results of the company for the quarter ended 30/09/2022 on 10/03/2023 on NSE
 - That the unaudited financial results of the Company for the quarter / half year ended 30/09/2022 got approved in the Board Meeting held on 05/11/2022 and were immediately conveyed to the Bombay Stock Exchange BSE (the only exchange on which the equity shares of the company were listed on that date) within 30 minutes from the end of the Board Meeting, in compliance with SEBI (LODR) Regulations, 2015.
 - That our Company got listed on your esteem exchange on 07/11/2022 i.e. after 2 days of the date of the Board Meeting for approval of the said results and when the said results were already in the public domain from the last two days.
 - However, on receipt of an email from NSE on 11/11/2022 (requiring us to submit the results by 14/11/2022 even if those had been approved before the date of the Company's listing on the exchange) and as advised by NSE helpdesk, we emailed the same to the exchange on 14/11/2022 as we had not got the necessary user ID & password for uploading the results on NSE Digital Exchange Portal.
 - That on getting the necessary user ID & password & as advised by the NSE helpdesk, we immediately upload the results in pdf format on the digital exchange portal vide application no. 2022112141068 on the same date i.e. 14/11/2022.
