Scrutinizer's Report on voting through e-voting for Postal Ballot in terms of Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management & Administration) Rules, 2014

I Preeti Singhania, proprietor of P Singhania & Associates, Chartered Accountants, am pleased to present the report on the Postal Ballot conducted by SHREE VASU LOGISTICS LIMITED ("the Company") seeking consent of its Members for the Special Resolution as contained in the Notice of Postal Ballot dated January 13, 2023.

- In terms of provisions of Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014, I was appointed as the Scrutinizer by the Company on January 13, 2023 to conduct the Postal Ballot through e-voting as contained in the Notice dated January 13, 2023.

In terms of Sections 108 and 110 and other applicable provisions, if any, of the Companies Act, 2013 ("Companies Act") read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 ("Rules") and Secretarial Standard-2 issued by the Institute of Company Secretaries of India ("SS-2") read with the General Circular Nos. 14/2020 dated 8th April, 2020, 17/2020 dated 13th April, 2020, and 20/2021 dated 8th December, 2021 and 3/2022 dated 5th May 2022 issued by the Ministry of Corporate Affairs and other applicable circulars ("MCA Circulars") and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, ("Listing Regulations") and SEBI Circular No. SEBI/HO/CFD/CMD2/CIR/P/2022/62 and other applicable provisions of the Act, Rules, Circulars and Notifications issued thereunder (including any statutory modification(s), clarification(s), substitution(s) or re-enactment(s) thereof for the time being in force and as amended from time to time), that the Resolutions as set out in this Notice are proposed for seeking approval of Members of the Company through Postal Ballot only by way of electronic voting ("Remote e-voting").
- The Management of the Company is responsible for ensuring compliance with the requirements of the Companies Act., 2013 and Rules relating to voting through votes through electronic means on the Resolutions contained in the Postal Ballot notice dated January 13, 2023.

Our responsibility as a Scrutinizer for the e-voting process is restricted to make a Scrutinizer report of the votes cast "in favour" or "against" the resolution based on the votes submitted by the shareholders through e-voting system provided by the Central Depository Services (India) Limited (CDSL), the authorized Service provider, for extending the facility of electronic voting to the Shareholders of the Company.

 - a. In view of the aforesaid MCA and SEBI circulars, soft copy of Postal Ballot Notice is being sent only through electronic means to those members whose e-mail addresses are registered with company/depository.
 - As confirmed by the Company the Postal Ballot Notice was also available on the website
 of the company www.shreevasulogistics.com.
 - c.
