# Singapore's top court stays execution of Malaysian Indian

AGENCIES Singapore

A 33-year-old Indian-origin Malaysian man's execution was stayed on Tuesday by Singapore's top court after the convicted drug trafficker. believed to be mentally challenged, tested positive for Covid.

Nagaenthran K Dharmalingam was to be hanged at Changi Prison for drug trafficking on Wednesday. Singapore's High Court on Monday suspended his scheduled execution until an appeal is heard during an online hearing.

Nagaenthran, who has been on death row for 11 years, was ushered in briefly into the dock at the Court of Appeal for the hearing of a last-ditch appeal against his death sentence, Channel

News Asia reported. However, he was later

abruptly taken away, and a judge informed the court that Nagaenthran had tested positive for Covid. Justice Andrew Phang,

who appeared with fellow judges Judith Prakash and Kannan Ramesh, said, "this is rather unexpected". He said the court was of

the view that it was not appropriate to proceed, "given the circumstances"

"The execution is sched uled for tomorrow," said Justice Phang .. If the applicant has

tenced to death in 2010 for importing 42.72g of heroin into Singapore in 2009 in a bundle strapped to his thigh.

In December last year, century-old Shri Param Hans Ji Maharaj temple in Teri vil-Khyber lage in Pakhtunkhwa's Karak district was vandalised and demolished by a mob led by some local clerics belonging to the Jamiat Ulema-e-Islam Fazl (JUI-F).

Chief Justice Ahmed at the time ordered authorities to reconstruct the temple and instructed them to recover the money for the restoration work from the attackers whose act had caused "international embarrassment" to Pakistan.



#### Sops for power

Two new tehsils Killod and Mundi will be carved out in Khandwa district Digoda in Tikamgarh district and Dhoolkot tehsil in Burhanpur district. State Cabinet also approved proposal to change name of newly-formed Chhind wara University to Raja Shankar Shah University. CM Chouhan had made an announcement regarding this on September 18 in Jabalpur. Cabinet also approved the proposal to open 11 new government colleges and to start science and commerce faculty in five existing colleges. Moreover, sanction for 233 academic and 228 non-academic posts were also approved. Cabinet approved 138 new posts for TN Hospital in Bhopal that would be upgraded to Regional Institute for Respiratory Diseases.

#### **CRIMINAL NEGLIGENCE**

"This was unfortunate incident and (outcome of) a criminal negligence. The Additional chief secretary Health and Medical Education will investigate the incident and strict action will be taken against the guilty", he added. Praising the hard work of minister for Medical Education Vishwas Sarang, who immediately rushed to the hospital on getting information about the fire, the CM said who put their lives at risk to rescue the children deserve appreciation. Such doctors, nurses, ward boys etc would be honoured. The CM said Sarang reached the spot as soon as he got the information about the incident and immediately coordinated the relief work. The CM also thanked the police administration and the team of doctors for taking prompt action and saving the lives of children. He further said, "I had a desire to reach the spot immediately. I constantly remained in touch with Sarang. I was told that my going there may divert the attention of the people engaged in the relief work. The focus of the teams should be on evacuation of children safely."

#### Hospital ignored BMC...

There was yet another notice dated June 22, 2021 by the additional commissioner, BMC to all the hospitals in Bhopal to get the NoC regarding compliance of the fire safety norms.

The BMC also warned that if the hospitals didn't comply with the notice within a month a recommendation would be made to get their licences cancelled.Public health expert Amulya Nidhi says the government's admission that the fire incident took place due to a short circuit at Kamala Nehru suggests that had the hospital chosen to comply with the fire safety norms to get the NoC the fatal incident could have been averted and several lives could have been saved.Amulya Nidhi said BMC was equally responsible for the incident as it slept over its own notices and didn't take follow-up action.

Despite efforts the BMC commissioner and the hospital authorities couldn't be reached for their comments. JUDICIAL INQUIRY: Meanwhile, leader Opposition in the state assembly and state Congress president Kamal Nath dubbed the inquiry by ACS, Health Mohd Suleman as an eyewash aimed at, he alleged, covering up the flaws in the system and shield those responsible for the incident.Nath demanded a judicial inquiry instead, that too with a sitting judge of high court.

#### Two minor girls...

Sunil Barkare, SDOP of Begumganj in Raisen district, said the 12-year-old victim had returned early from school and was alone at home when the minor boy, aged 17, entered her house and committed the crime, he said. When the girl's neighbour, aged 28, saw the incident, he also raped her, the police officer said. The 28-year-old accused was arrested on Monday, while the minor boy is absconding, he said. In Khandwa district, three persons abducted and raped the 15-year-old girl when she was sleeping at her relative's home on Saturday night at a village, Harsud Police Station incharge Ishwar Singh Chouhan said. After finding that the girl was missing, family members launched a search and found her in injured near the home, he said. Later, the girl narrated her ordeal to her family members, who subsequently filed a police complaint, Chouhan said. Chouhan further said one of the three accused has been arrested. In both the cases, the accused have been booked under relevant sections of the Indian Penal Code (IPC) and the Protection of Children from Sexual Offences Act (POCSO Act).

#### **1.6 YEAR OLD...**

They said that rain water would enter their house and fields through the pipe. Because of the conflict, some villagers sat on the road. After that, police force was summoned to remove the agitating villagers. According to the villagers, the police began lathi charge and it hit the child, due to which she died. At the same time, the villagers also pelted stones and SI Raghavendra Yadav received injuries. On getting the information, SP Rajesh Singh Chandel, Collector Akshay Kumar Singh and Karaira MLA Pragilal Jatav reached the spot. According to the MLA, he has spoken to the villagers to pacify the situation. A large number of police forces have, however, reached the spot after the dispute.

#### Can courts override...

"Can the highest constitutional court say that we will override the defence needs, particularly in view of the recent past? Can we say that environment concerns will triumph over the defence needs of the nation?" it asked, adding, "Is it appropriate to say that defence concerns be taken care of so that environmental degradation does not take place?"

The bench told senior advocate Colin Gonsalves, representing the petitioners: "We must tell you our predicament in this. If the Centre says that they are doing it for tourism, then we understand and we can impose more stringent conditions." But when it is needed to defend the borders, then it is a serious predicament, Justice Chandrachud said. Gonsalves cited the catastrophic impact of road expansion on young mountains like the Himalayas and added that parliamentary expert committee reports suggest Himalayas may not be able to bear the road construction. The AG argued that there are several projects leading to international borders, which are needed for Army movements and the Army was ignored in this matter, however now its needs must be brought on record. The top court was hearing a plea filed by NGO 'Citizens for Green Doon' seeking direction to stop felling of trees without clearances on the Ganeshpur-Dehradun Road (NH-72A), which is a part of the Delhi-Dehradun expressway. The hearing in the matter will continue on Wednesday.In 2018, the Centre's notification said that the road width cannot exceed 5.5 metres in the hilly terrains like the one through which Chardham project is proposed. In September 2020, the top court directed the government to keep the width of the Chardham road at 5.5 metres. However, in December 2020, this notification was amended. The Chardham highway is a 900-kilometre road project to provide all-weather connectivity to four Hindu pilgrimage centres in Uttarakhand.

# **Dam feud: Kerala loses more ground**

Kerala is getting into an increasingly untenable situation with regard to the Mullapperiyar dam, with pressures from possibly all directions working against the interest of the state. The latest development in a continuing muddle is a recommendation from the central government to do everything that Tamil Nadu has been demanding by way of helping in the strengthening of the baby dam.

The central water resources secretary has sent a letter to the Kerala chief secretary, asking the state to cooperate in strengthening the baby dam as well for maintenance of the main dam.

This will facilitate Tamil Nadu to raise the water level in the main dam to 142 feet, which the people living in the downstream areas of the dam consider as lifethreatening. Meanwhile, the

Pinarayi Vijayan government has been tying itself in knots, trying to run away from the responsibility of granting permission to cut 15 trees in the baby dam catchment, which happens to be part of the Periyar tiger reserve. trees Forest minister AK Saseendran has been caught in a predica-

ment, in which he has had to deny any knowledge of the tree cutting plan, even as it emerged that the decision was taken after much deliberations at the highest level, including a joint inspection of the area and identification of the trees to be cut by a team comprising the representatives of both the states.

The government plan to extricate itself from the tricky situation by taking action against the chief forest conservator and wild life warden has run into a roadblock as it has become clear they were only acting on the decisions arrived at by the joint consultacourt.

Amid an uproar both within the state assembly and outside that the Vijayan government has failed to protect the interests of the state, the government had frozen the permission to cut the

But the disclosure of joint consultations at the official level has held back the govt, which has since decided to refer the matter to the advocate general for legal opinion. It turns out the original pact between the states for the construction and upkeep of the 126-year old dam had provided for cutting of trees in the catchment area if that was warranted for the upkeep of the structures.



## 'Before a catastrophe occurs…disband it'

OUR BUREAU / NEW DELHI: The Kerala government has asserted in its latest affidavit before the Supreme Court that no amount of rejuvenation by any means can perpetuate the 126year old deteriorated Mullaperiyar dam, whose failure any day could have a cascading effect on the Idukki dam downstream, threatening lives and properties of 50 lakh people. It has urged the apex court to reduce the maximum permissible water level in the reservoir, which is currently fixed at 142 feet, and also emphasized that as a long-term measure, a new dam should be built downstream and Mullaperiyar should be decommissioned.

Rape, murder victims' age insufficient for

death penalty: SC NEW DELHI: Low age of victims in rapeand-murder cases has not been considered as the "only or sufficient factor by this court" for imposing the death penalty, the Supreme Court has said referring to its verdict that had analysed 67 similar cases dealt by it in the last 40 years. The sc's crucial observation came on an appeal of Irappa Siddappa who was convicted and given the death penalty by a trial court. The Karnataka High Court confirmed

the trial court's decision on March 6, 2017. He was convicted for kidnapping, rape and murder of a five-year old-girl in the village of Khanapur in Karnataka in 2010 and post the incident, he had put the body of the victim in a bag and thrown it into a stream, named Bennihalla. A bench comprising Justices L Nageswara Rao, Sanjiv Khanna and BR Gavai confirmed the conviction of Siddappa for offences including rape, murder and destruction of evidence, but set aside the award of death penalty, which was handed down by courts below on grounds including the minor age of the victim, and commuted it to life imprisonment for a period of 30 years. 'We find sufficient mitigating factors to commute the sentence of death imposed by the Sessions Court and confirmed by the High Court into imprisonment for life, with the direction that the appellant shall not be entitled to premature release/remission for the offence under Section 302 (murder) of the Code until he has undergone actual imprisonment for at least thirty years,' said the verdict penned by Justice Khanna for the bench.

Mumbai police have traced the driver of a car whose passenger had asked a cabbie about the location of industrialist Mukesh Ambani's residence 'Antilia' here, an official said on Tuesday.

The driver of that car, a private cab, was brought to the Azad Maidan police station here for questioning after the vehicle were traced to neighbouring Navi Mumbai late Monday night, the official said.

Security was beefed up on Monday outside industrialist Ambani's residence after a taxi driver informed the police that two suspected passengers in a vehicle carrying bags with them had asked him about the location of 'Antilia', a 27storey building located on Altamout Road in south Mumbai.

## Reeling under rain havoc TN braces for more

#### CHENNAI

Even as it is reeling under the impact of rain fury, Tamil Nadu is bracing for more trouble with the Met Department predicting further rain over the next five days.

The state government has put the death toll so far, due to rains, at five. State Revenue and Disaster Management Minister K.K.S.S.R. Ramachandran said that water is being pumped out of low-lying areas after lull in rainfall on Tuesday. He said that rescue operations are underway by the NDRF, army, and Fire Department personnel.

Across the state, educational institutions in 14 districts have had to suspend classes due to the continued rainfall. A depression is expected

to form over southeast and southwest Bay of Bengal due to cyclonic circulation gathering strength over the area. and the Met Department expects it to hit the coast of north Tamil Nadu in the next 36 hours.

As a result, fairly widespread to widespread light to moderate rainfall is possible across Tamil Nadu, south coastal Andhra Pradesh, and Kerala, over the next five days, the Met Department has said. The India Meteorologi-

cal Department (IMD) has issued red alerts for Pudukkottai, Ramanathapuram, Karaikal for Tuesday. Similarly, red alerts have been sounded for Cuddalore, Viluppuram, Sivaganga, Ramanathapuram and Karaikal, on Wednesday.
