State to share the cost for Gadag-Yelavagi railway Line: CM

CHIEF Minister **Basavaraj Bommai** on Tuesday gave assurance that the State government will give its share of ₹600 crore for the Gadag-Yelavagi new railway line project.

Addressing the Jan Sankalp Yatra rally in Shirahatti, he said approval for the Tamagonda project will be given very soon and that the Jaalawadagi irrigation scheme will be started soon. Steps will be taken to develop Shirahatti and Mundargi as tourism spots. All Lambani tandas will be declared as revenue villages within one month and title deeds for every house in tanda will be distributed in a month. Stating that all demands of the Gadag district will be fulfilled, the chief minister said the demand of ₹one crore towards Kanakadasara Auditorium at Shirahatti will be released soon. Already, the government has distributed input subsidies of ₹209 crore to 1.2 lakh farmers of Gadag district towards crop loss due to rains. Besides this, ₹97 crore crop insurance money has been disbursed to the district. A sum of ₹159 crore has been granted to Gadag under the PM Kisan scheme.

FOR the last few years, the district has been trying to improve the results of students in the SSLC examination. It has been leaving no stone unturned to remain in the top position in the State as far as exam result is concerned. This year too, the Education Department is employing various meth-

ods to achieve the goal.

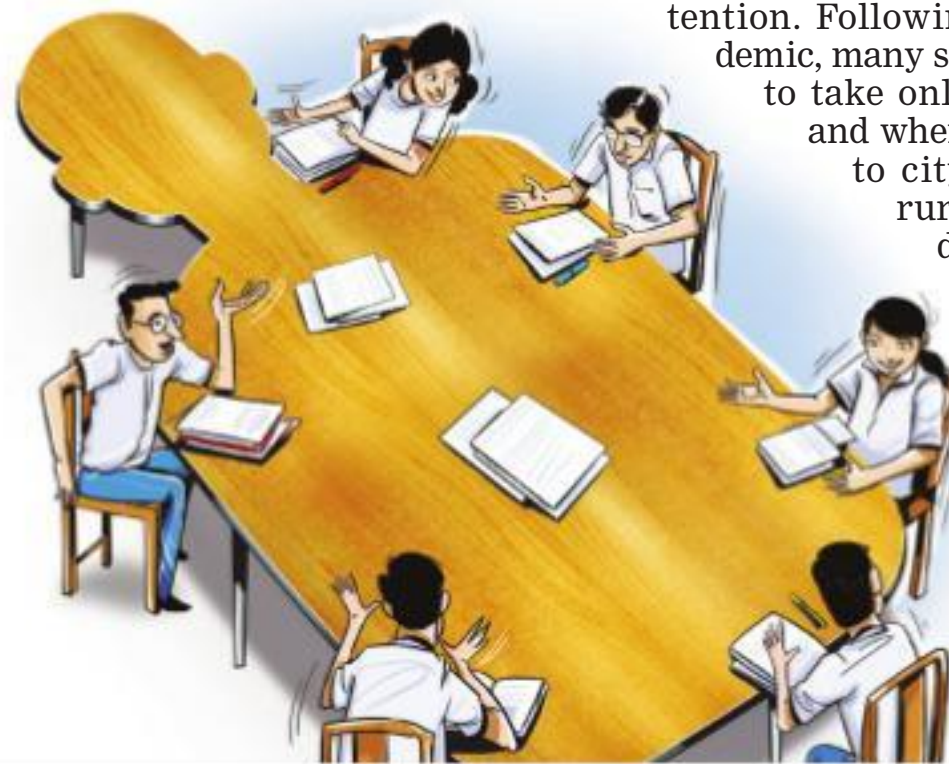
In the last couple of years, the department has introduced various methods like extra classes, examinations for slow learners, full-day school on Saturday and off days, providing notes and many more. These measures have improved the performance of the students and have also yielded good results.

Education experts say that rural area students need more attention. Following the pandemic, many students had to take online classes and when compared to city students, rural area students lack digital education facilities, a f-

fecting their performance. Such students have been promoted but need to brush up on their knowledge.

“The news of increasing Covid-19 cases in other nations is also demoralising some of the students. They are under the impression that they may also get promoted akin to previous years, a measure taken considering the conditions during the pandemic. The students should know that no such things will happen and they need to study to get a good score. All the required support will be given by their school teachers,” he added.

An Education Department officer said they have asked the school heads to prepare a list of slow learners and such students will be getting help from subject experts. “Prepared notes, possible questions and other such materials will be given to them. The number of class tests will be increased in such a way that students do not get overburdened. The examination pattern will be akin to annual examinations so that students get used to it,” he said.
