The consequences of compulsory delisting include the following:-

- The above companies will be ceased to be listed on the Stock Exchange. They shall be moved to the dissemination board of the Stock Exchange.
- In terms of Regulation 24 of Delisting Regulations, the delisted company, its whole-time directors, promoters and group companies shall be debarred from accessing securities market for a period of 10 years from the date of compulsory delisting.
- The onus of giving exit opportunity to the public shareholders and providing information to the stock exchanges for fair valuation is on the promoters of the company. In case exit is not provided by the promoters, appropriate action would be taken against them.

Any person who may be aggrieved by the proposed delisting may make representation, if any, to Delisting Committee of the Exchange in writing on or before February 28, 2018.
